thence along the northeast line McFarland Drive on a curve to the left having a radius of 441.65 feet, a delta of 05 degrees 57 minutes 08 seconds, a chord bearing and distance of South 36 degrees 17 minutes 05 seconds East 45.86 feet to an iron pin set, the principle place of beginning for this parcel;

thence leaving the northeast line of McFarland Drive North 53 degrees 50 minutes 26 seconds East 97.76 feet to an iron pin set;

thence South 87 degrees 32 minutes 47 seconds East 34.68 feet to an iron pin set;

thence South 42 degrees 12 minutes 25 seconds East 199.08 feet to an iron pin set on the northwest right of way of Maysville Pike (US 22);

thence along the northwest right of way of Maysville Pike (US 22)South 47 degrees 05 minutes 00 seconds West 116.83 feet to an iron pin set on the northeast line of McFarland Drive;

thence leaving the northwest right of way of Maysville Pike (US 22) and along the northeast right of way of McFarland Drive North 43 degrees 47 minutes 00 seconds West 200.00 feet to a point;

thence continuing along the northeast line of McFarland Drive on a curve to the right having a radius of 441.65 feet, a delta of 04 degrees 34 minutes 41 seconds, a chord bearing and distance of North 41 degrees 29 minutes 41 seconds West 35.28 feet to the principle place of beginning, containing 0.62 acres, more or less.
