distance of 745.85 feet to a point in the centerline of
Shaw Road and the true place of beginning for the parcel
herein intended to be described; thence south 24 degrees
13 minutes 39 seconds west along said centerline a distance
of 71.95 feet to a point; thence north 85 degrees 00 minutes
00 seconds west along the northerly line of lands now or
formerly owned by J. Kennedy and recorded in deed book 267,
page 453 of the deed records of said county a distance of
164.13 feet to an iron pin and passing through an iron pin

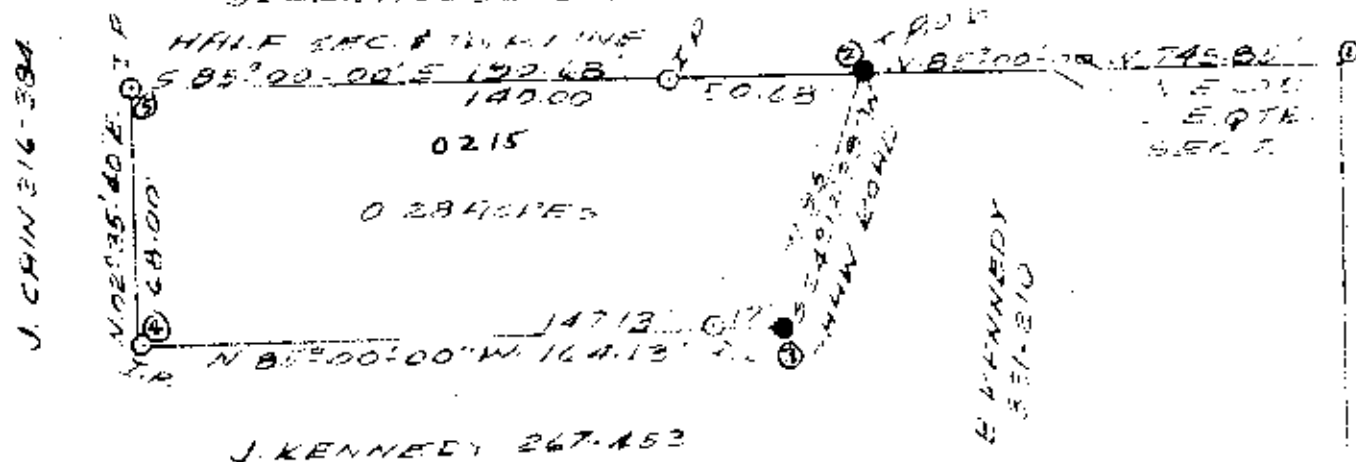
