Situated in the State of Ohio, County of Muskingum, Township of Newton, Township 15, Range 14, part of the Southwest Quarter of Section 1, bounded and described as follows:

Commencing at a railroad spike found at the Northwest corner of the Southwest Quarter of Section 1 in the center of Greenhouse Road; thence along the North line of said section and in Greenhouse Road South $83^{\circ} 40' 29''$ East 218.11 feet to a point; thence leaving Greenhouse Road and the North line of the Southwest Quarter of Section 1 South $0^{\circ} 38' 01''$ West along the West side of a 60.00 foot wide right-of-way 256.07 feet to an iron pin set, passing an iron pin set at 20.29 feet; thence continuing along said 60.00 foot wide right-of-way South $23^{\circ} 31' 28''$ East 109.69 feet to an iron pin set, the place of beginning; thence South $23^{\circ} 31' 28''$ East 177.35 feet to an iron pin set; thence South $33^{\circ} 17' 53''$ West 515.85 feet to an iron pin set; thence South $59^{\circ} 41' 00''$ West 166.37 feet to an iron pin set on the West line of the Southwest Quarter of Section 1; thence along the section quarter line North $5^{\circ} 18' 21''$ East 662.97 feet to an iron pin set; thence North $86^{\circ} 34' 36''$ East 295.24 feet to the place of beginning, containing 3.87 acres more or less.

Bearings are based on the North line of the Southwest Quarter of Section 1 bearing South $83^{\circ} 40' 29''$ East.

Being a part of Auditor's Parcel Number 47-47-16-01-01-000.

Above parcel is also subject to the right-of-way of Columbia Gas line.

Iron pins set are No. 5 reinforcing bars 30 inches long with plastic I. D. caps.

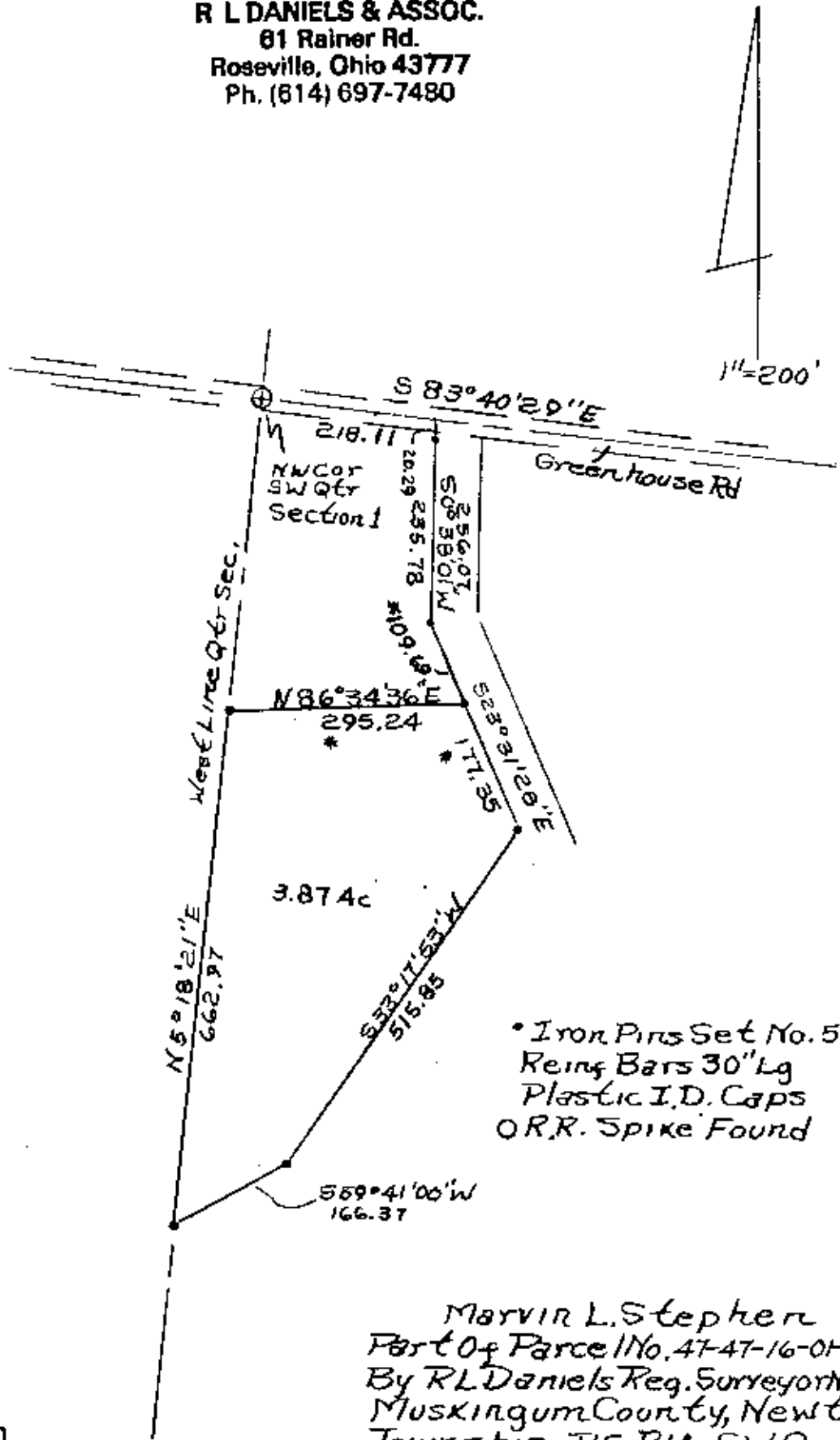
