

## DESCRIPTION OF SURVEY FOR TRAVIS CARSON

Situated in the State of Ohio, County of Muskingum, Township of Newton:

Being part of the Northeast Quarter, Section 7 and Northwest Quarter of Section 8, Township 15, Range 14, of the Congress Lands East of the Scioto River, US Military District, **being part of** the Rodger D Carson Trustee and Deborah J Carson Trustee property recorded in **Official Record Volume 2022, Page 502** of said county's deed records, further **being part of** Muskingum County **Auditor's Parcel Number 47-20-01-10-000**, and more particularly described as follows;

Commencing at an iron pin (found) at the common corner for Sections 5, 6, 7, and 8 of said Township and Range;

- TIE-1 THENCE South 03 degrees 00 minutes 09 seconds West 1921.28 feet** along the common line for Sections 7 and 8 to an unmarked point on the South line of the Travis Carson property recorded in Deed Book Volume 1152, Page 393, further being the place of beginning for the property herein intended to be described;
- #1- THENCE South 84 degrees 56 minutes 18 seconds East 9.77 feet** into Section 8 and along said Travis Carson property to an unmarked point in the centerline of Stine Road (Township Road 276);
- #2- THENCE with a curve to the left having, a chord bearing South 11 degrees 54 minutes 59 seconds East 184.26 feet, a radius of 421.00 feet,** and arc length of 185.76 feet along said road and common line for said Rodger and Deborah Carson property and for the Myra S Hartman Trustee property recorded in Deed Book Volume 1152, Page 324 and the Matthew J Milatovich and Audra J Milatovich property recorded in Official Record Volume 2598, Page 428 to an unmarked point;
- #3- THENCE South 24 degrees 33 minutes 25 seconds East 124.53 feet** continuing along said road and common line for said Rodger and Deborah Carson and Milatovich properties to an unmarked point;
- #4- THENCE South 23 degrees 07 minutes 16 seconds East 49.39 feet** continuing along said road and properties to an unmarked corner of the Linda Sue Dicks and Janice E Brown property recorded in Official Record Volume 1854, Page 302;
- #5- THENCE South 74 degrees 13 minutes 07 seconds West 102.43 feet** leaving said road and along a common line for said Rodger and Deborah Carson and Dick/Brown properties to an iron pin (found), passing an iron pin (found) at 26.43 feet;
- #6- THENCE South 81 degrees 36 minutes 30 seconds West 99.69 feet** continuing along said properties to an iron pin (found), passing into Section 7 at 40.39 feet;
- #7- THENCE South 73 degrees 55 minutes 53 seconds West 45.40 feet** continuing along said properties to an iron pin (found);
- #8- THENCE South 74 degrees 09 minutes 04 seconds West 55.91 feet** continuing along said properties to an unmarked corner, from which an iron pin (found) on a common line for said properties for reference bears South 05 degrees 57 minutes 33 seconds West 12.85 feet;
- #9- THENCE North 85 degrees 41 minutes 49 seconds West 77.83 feet** through said Rodger and Deborah Carson property to an iron pin (set);
- #10- THENCE North 04 degrees 29 minutes 57 seconds East 98.52 feet** continuing through said property to an iron pin (set);
- #11- THENCE North 65 degrees 09 minutes 34 seconds West 137.88 feet** continuing through said property to an iron pin (set);
- #12- THENCE North 03 degrees 11 minutes 59 seconds East 279.99 feet** continuing through said property to an iron pin (found) at a corner of said Travis Carson property;
