Being a part of the Southwest Quarter of Section Seven (7), Township  
Fifteen (15 ), Range Fourteen (14 ) of the Congress Lands East of the Scioto  
River and part of property now owned by John D. and Virginia L. List and  
Recorded in Deed Book 655, Page 10 of the Muskingum County Deed Records  
bounded and described as follows:

Commencing at an iron pin found at the northeast corner of said south-  
west quarter of section 7; thence south 3 degrees 37 minutes 13 seconds west  
( the base of bearings for this description true north by sun hour angle  
method ) along the east line of said southwest quarter 1829.63 feet to an  
iron pin set in the center of an old road at the true place of beginning  
for the following described parcel; thence continuing south 3 degrees 37  
minutes 13 seconds west along the east line of said southwest quarter  
428.63 feet to a spike found in the center of Bagley Road at the southwest  
corner of C. Moore ( Vol. 695, Pg. 542 ) and passing through an iron pin  
found at the northwest corner of said Moore property at 259.83 feet and  
passing through an iron pin set at 367.63 feet; thence north 30 degrees  
56 minutes 10 seconds west along the center of said road 28.43 feet to a  
railroad spike set; thence along the center of said Bagley road on a  
curve to the left having a radius of 147.72 feet ( the long chord of which  
bears north 57 degrees 53 minutes 20 seconds west 133.91 feet ) an arc  
distance of 138.98 feet to a railroad spike set; thence north 84 degrees  
50 minutes 30 seconds west along the center of said road 72.98 feet to a  
railroad spike set; thence north 36 degrees 48 minutes 37 seconds east  
186.76 feet to an iron pin set and passing through an iron pin set at 27.00  
feet; thence north 8 degrees 06 minutes 47 seconds east 185.18 feet to an  
iron pin set; thence south 85 degrees 24 minutes 28 seconds east 90.04 feet  
to the true place of beginning containing one and fifty eight thousands  
( 1.058 ) acres more or less.

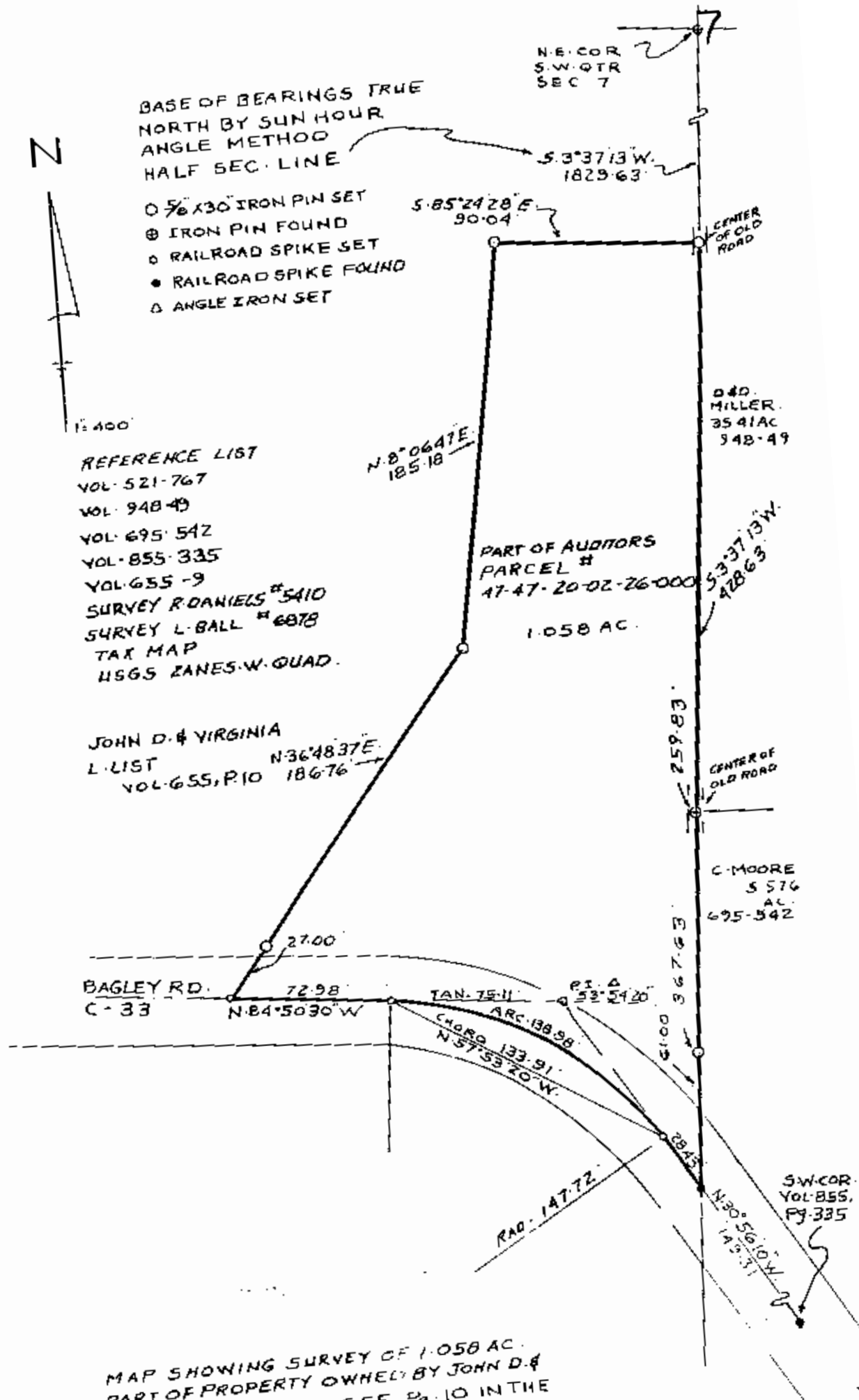
