

Situated in the State of Ohio, County of Muskingum, Township of Newton:

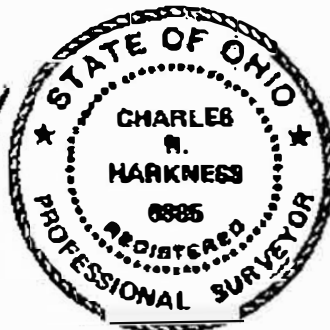
Being part of the North Half, of the Northeast Quarter, of Section #8, of Township #15, Range #14, of the Congress Lands East of the Scioto River, **being part of the Donald H Smith and Jacquelyn M Smith property recorded in Deed Book Volume 1058, Page 543, of said county's deed records, further being part of Muskingum County Auditor's Parcel Number 47-22-01-02-000, and more particularly described as follows;**

- #1- Beginning at an iron pin (set) at the Center of said Northeast Quarter of Section #8; **THENCE North 87 degrees 39 minutes 05 seconds West 925.26 feet** along the common line for the North Half and Southwest Quarter of the Northeast Quarter of Section #8 to an unmarked point in the centerline of Foxfire Drive (Township Road #128), passing an iron pin (set) at 891.24 feet;
- #2- **THENCE North 49 degrees 09 minutes 30 seconds East 237.91 feet** continuing along said road and common line for said Smith and Denny property to an unmarked point;
- #3- **THENCE North 52 degrees 12 minutes 55 seconds East 154.71 feet** continuing along said road and properties to an unmarked point;
- #4- **THENCE along a curve to the left having, a chord bearing North 43 degrees 38 minutes 05 seconds East 417.75 feet, a radius of 1561.56 feet, and arc length of 419.00 feet,** continuing along said road and properties to an unmarked point;
- #5- **THENCE along a curve to the right having, a chord bearing North 57 degrees 41 minutes 45 seconds East 292.81 feet, a radius of 395.12 feet, and arc length of 299.96 feet,** continuing along said road and properties to an unmarked point;
- #6- **THENCE along a curve to the left having, a chord bearing North 69 degrees 18 minutes 55 seconds East 275.10 feet, a radius of 782.07 feet, and arc length of 276.54 feet,** continuing along said road and properties to an unmarked point;
- #7- **THENCE North 59 degrees 11 minutes 40 seconds East 225.35 feet** continuing along said road and properties to an unmarked point;
- #8- **THENCE South 31 degrees 29 minutes 40 seconds East 394.95 feet** leaving said road and through said Smith property to an iron pin (set), passing an iron pin (set) at 32.68 feet;
- #9- **THENCE South 32 degrees 33 minutes 15 seconds West 246.37 feet** continuing through said Smith property to an iron pin (set);
- #10- **THENCE South 46 degrees 32 minutes 20 seconds West 603.72 feet** continuing through said Smith property to the place of beginning, containing **16.24 acres**, of which 0.74 acres are within the right of way for Foxfire Drive (Township Road #128).

The bearings within this description are based on State Plane Coordinate Grid (Ohio South 1983) derived from GPS Observations. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.6885).

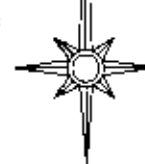

SURVEYOR'S NOTES AND REFERENCES:

Muskingum County Tax Maps and Orthophotos of the area. Survey completed by Charles R Harkness of the Jacqueline Campbell property (Job #1750-3) dated 3-6-2009.

Note #1-North line of SW Qtr of NE Qtr parallel with South line. Mid-point of West line of NE Qtr fits with long term occupation East of Foxfire Drive. Survey pins not used are inconsistent with the Qtr Sec Information, but do align with the exiting fence in this area.

Note #2-0.74 acres of the surveyed parcel is within to 40' Right of way of Foxfire Drive (TR #128).
