

## Eugene and Lois Folden

Situated in the State of Ohio, County of Muskingum, Township of Newton, Township 15, Range 14, part of the West half of Northeast quarter of Section 8, bounded and described as follows:

Being part of Eugene and Lois Folden OR Volume 1530, page 556, Parcel No. 47-22-01-04-000

Beginning at a stone found at the Southeast corner of the West half of the Northeast quarter of Section 8, from which an X in a large stone at the Southwest corner of the West half of the Northeast quarter of Section 8 bears South 85°36'38" West 1333.90 feet; Thence South 85°36'38" West along David and Leona Searls Deed Volume 510, page 528 316.08 feet to an iron pin set; Thence along the split line of Eugene and Lois Folden OR Volume 1530, page 657, the next three courses and distances - North 31°04'00" West 358.33 feet to an iron pin set, South 84°49'06" West 634.00 feet to an iron pin set, and North 89°30'14" West 308.52 feet to a point in the center of Township Road 128 (Foxfire) passing an iron pin set at 284.14 feet; Thence North 19°00'57" West in the center of said road 74.79 feet to a point; Thence leaving said road and along the split line of Eugene and Lois Folden, the next three courses and distances - South 89°30'14" East 327.18 feet to an iron pin set passing an iron pin set at 25.00 feet, North 04°37'41" West 243.16 feet to an iron pin set, and North 84°49'06" East 958.15 feet to an iron pin set on Donald Smith Volume 1058, page 543, West Line; Thence South 03°10'40" East along Donald Smith 676.82 feet to the place of beginning containing 10.00 Acres more or less.

Bearings are based on the South line of the Northeast quarter of the West half of Section 8 bearing South 85°36'38" West.

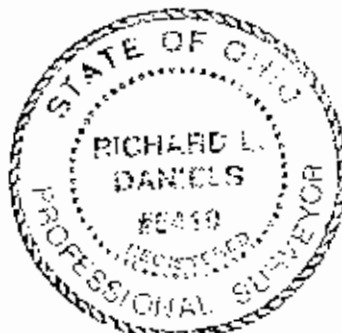

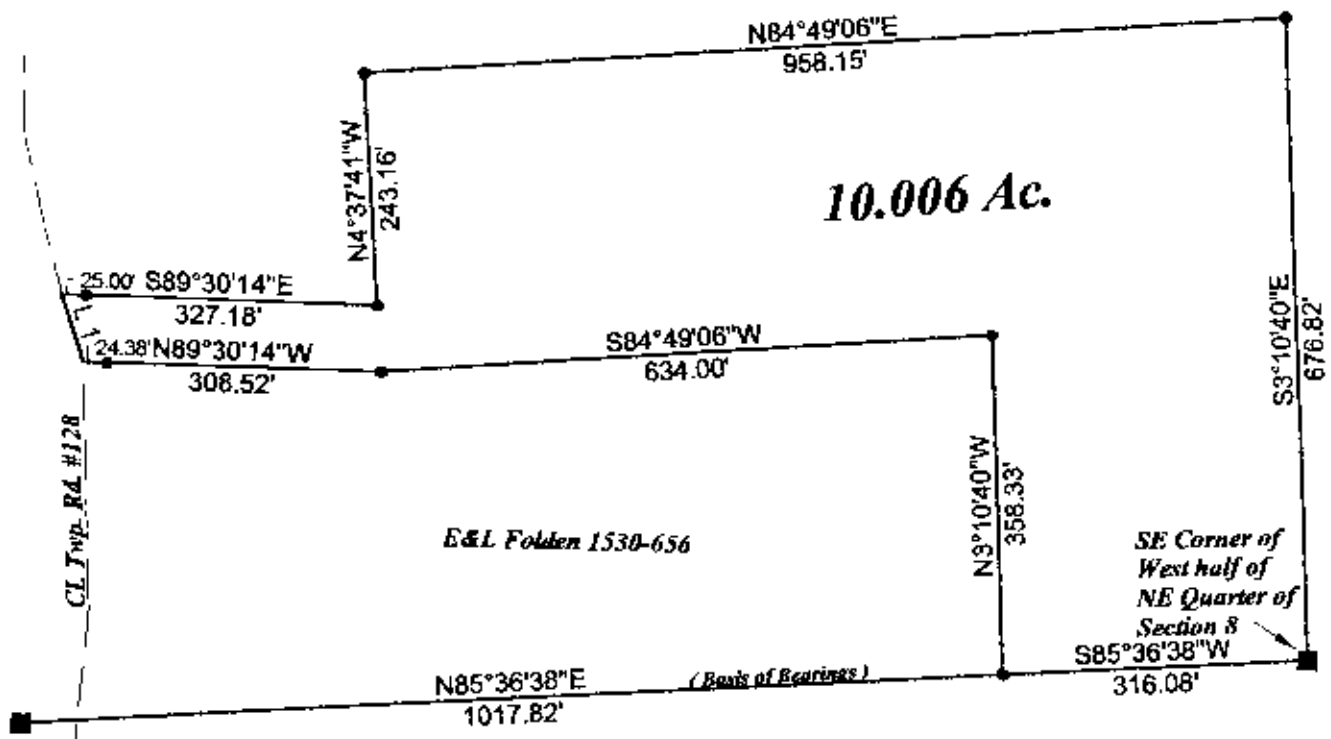
