Situated in the State of Ohio, County of Muskingum, Township of Newton, T- 15, R- 14, being a resurvey of Ronald L. & Betty J. Taylor Vol. 510 Pg. 853, being part of Section 8, and more particularly described as follows:

Beginning at an iron pin found at the Southeast Corner of Section 8; thence along the East line of Section 8 North 02 Degrees 54 Minutes 20 Seconds East 1336.29 feet to an iron pin found at the Northeast Corner of Allen Subdivision Plat Book 5 Pg. 75 and the place of beginning; thence along the North Line of Allen Subdivision North 87 Degrees 23 Minutes 57 Seconds West 345.35 feet to an iron pin set; thence North 02 Degrees 52 Minutes 40 Seconds East 1347.53 feet to an iron pin found; thence South 87 Degrees 23 Minutes 56 Seconds East 346.00 feet to a stone found at the Northeast Corner of the Southeast Quarter of Section 8; thence along the East Line of Section 8 South 02 Degrees 54 Minutes 20 Seconds West 1347.53 feet to the place of beginning, containing 10.693 acres, more or less, subject to all legal highways and easements.

Iron pins set are 5/8 inch rebar 30 inches long, with plastic ID caps.

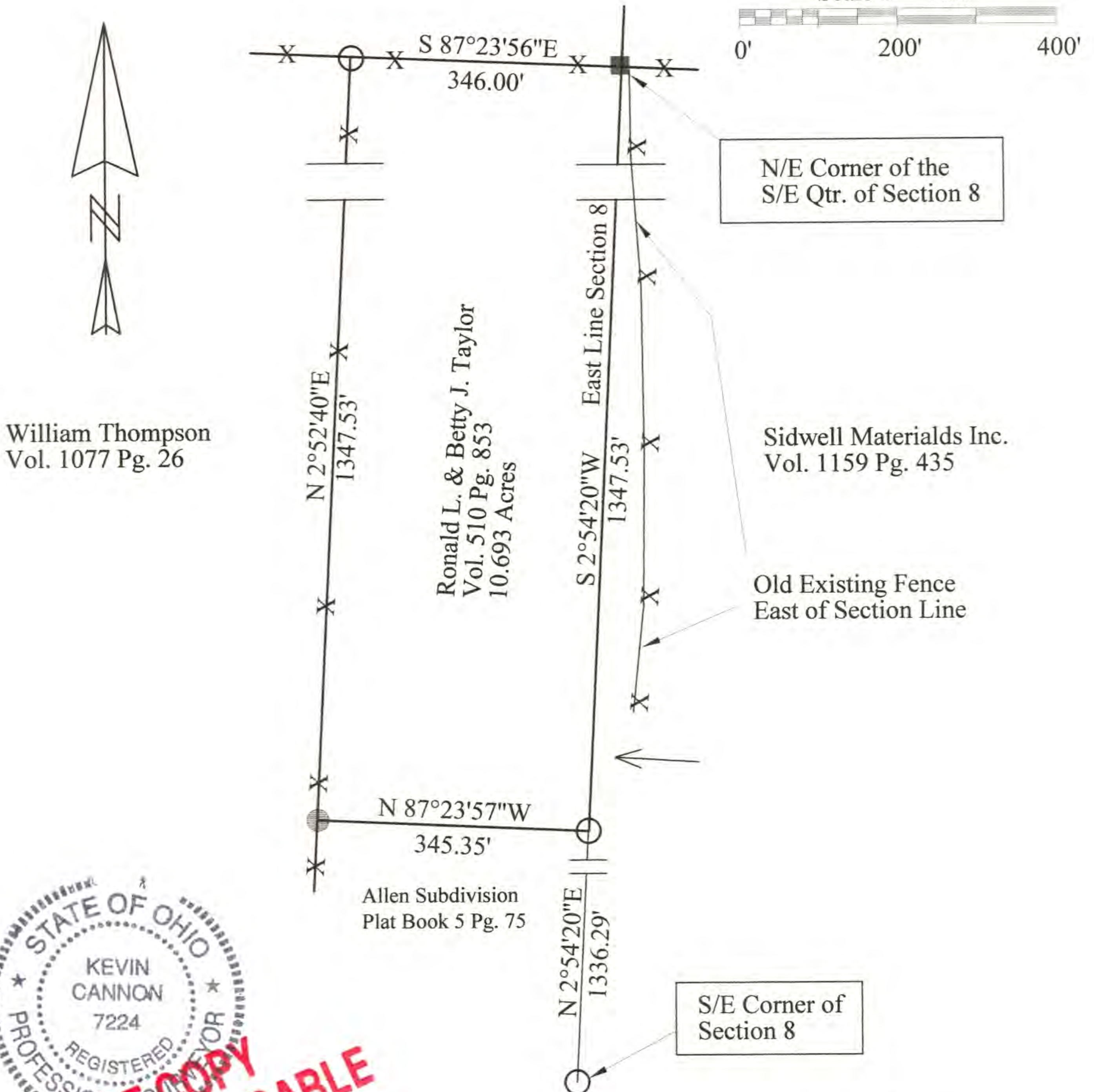
