Commencing at a stone found at the Northeast Corner of the Southwest Quarter of Section 8; Thence South 5°13'00" West along half section line 1154.89 feet to a point in center of Township Road 276; Thence along said road the following five courses and distances: North 45°19'00" West 55.90 feet to a point, North 46°45'00" West 196.09 feet to a point, North 55°58'00" West 135.87 feet to a point, North 71°19'00" West 161.57 feet to a point and North 81°10'00" West 218.66 feet to a point the place of beginning; Thence along the center of Twp. Rd. 276 the next 2 courses and distances: North 81°10'00" West 96.53 feet to a point, and South 89°04'00" West 137.44 feet to a point; Thence leaving Twp. Rd. 276 and along Steve Milatovich Vol. 572, Page 345, North 55°13'13" East 274.99 feet to an iron pin set; Thence South 02°20'50" East along the split line of Allen Milatovich Vol. 1118, Page 648, 169.58 feet to the place of beginning passing an iron pin set at 137.90 feet containing 0.426 acres more or less:

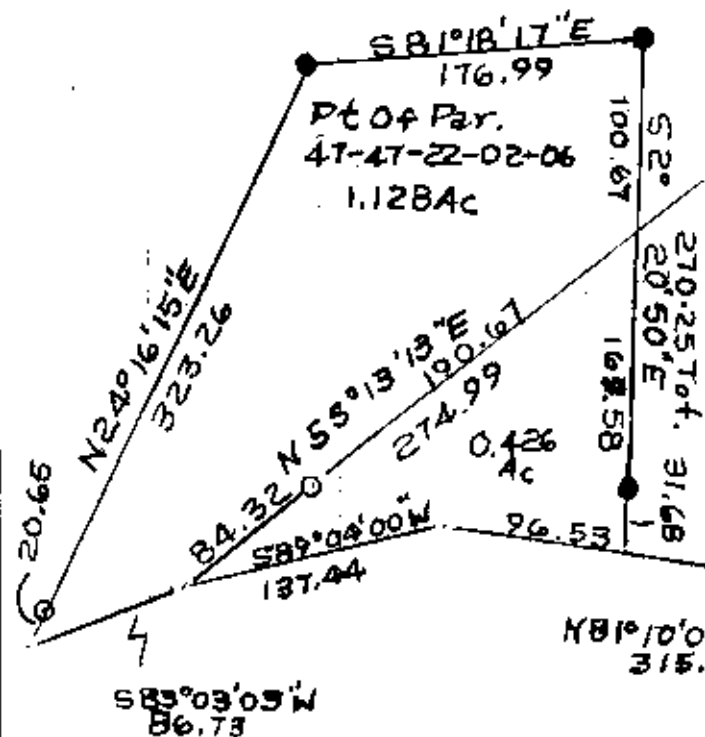
