Situated in the State of Ohio, County of Muskingum, Township of Newton, T-15, R-14, being a resurvey of Robert, Andrew & James McClelland Vol. 2778 Pg. 834, being a part of the Northeast Quarter of Section 9, and more particularly described as follows:

Beginning at an IPF at the Northwest Corner of the Northeast Quarter of Section 9; thence South 25 Degrees 27 Minutes 44 Seconds West 259.98 feet to an IPF;

Thence South 75 Degrees 17 Minutes 53 Seconds East 418.19 feet to an IPF;

Thence South 19 Degrees 57 Minutes 45 Seconds West 106.84 feet to an IPS and the place of beginning;

Thence South 85 Degrees 26 Minutes 33 Seconds East 485.47 feet to a 5/8" IPF, passing 5/8" IPF at 208.04 feet and 273.70 feet;

Thence North 02 Degrees 34 Minutes 33 Seconds East 278.36 feet to an IPS;

Thence South 78 Degrees 54 Minutes 21 Seconds East 159.47 feet to a 5/8" IPF;

Thence North 09 Degrees 21 Minutes 14 Seconds East 207.43 feet to a point in the centerline of Twp. Rd. 128, passing an IPF at 184.25 feet;

Thence along said centerline South 88 Degrees 24 Minutes 24 Seconds East 190.53 feet to a point;

Thence leaving said centerline South 09 Degrees 06 Minutes 53 Seconds West 253.00 feet to a 5/8" IPF on the North bank of a small creek, passing an IPS at 33.83 feet;

Thence along the North bank of said creek South 70 Degrees 34 Minutes 01 Seconds East 122.66 feet to a point;

Thence along the North bank of said creek South 35 Degrees 59 Minutes 48 Seconds East 83.44 feet to a point;

Thence along the North bank of said creek South 88 Degrees 51 Minutes 41 Seconds East 101.53 feet to a 5/8" IPF;

Thence North 09 Degrees 07 Minutes 09 Seconds East 227.35 feet to a 5/8" IPF;

Thence South 83 Degrees 58 Minutes 45 Seconds East 175.79 feet to a 5/8" IPF;

Thence North 10 Degrees 39 Minutes 27 Seconds East 133.34 feet to a point in the centerline of Twp. Rd. 128 ( Foxfire Drive ), passing a 5/8" IPF at 119.18 feet;

Thence along said centerline the next 3 courses to points: South 84 Degrees 25 Minutes 32 Seconds East 141.25 feet;

Thence South 84 Degrees 32 Minutes 06 Seconds East 99.57 feet;

Thence South 87 Degrees 23 Minutes 40 Seconds East 148.43 feet;

Thence leaving said centerline South 10 Degrees 17 Minutes 02 Seconds West 832.18 feet to a 1" iron pipe found, passing an IPS at 29.25 feet and an axle found at 218.00 feet;

Thence North 87 Degrees 09 Minutes 16 Seconds West 1717.72 feet to a 5/8" IPF;

Thence North 19 Degrees 57 Minutes 45 Seconds East 402.54 feet to the place of
