Being part of the prior deed reference Volume 833, Page 242 of said County's deed records, also being part of Muskingum County Auditor's Parcel Number 47-47-27-01-32-000, and more particularly described as follows;

Commencing at the Northwest corner of said Northeast Quarter of Section #10; thence along the West line of said Northeast Quarter as described in the prior deed reference Volume 833, Page 242 South 482 feet; thence along the South line of property described in deed reference Volume 844, Page 181 and described in said prior deed reference S 83 40 E 260 feet to an axle (found) at the Southeast corner of said Volume 844, Page 181; thence S 28 22 27 E 36.00 feet to an iron pipe (found) at the Northwest corner of said prior deed reference; thence along the West line of said prior deed reference S 28 22 27 E 584.00 feet to an iron pin (set) at the place of beginning for the property herein intended to be described; thence through said prior deed reference N 60 02 50 E 462.23 feet to an iron pin (set) on the East line of said prior deed reference; thence along said East line S 39 22 28 E 261.15 feet to an iron pipe (found) at the Southeast corner of said prior deed reference; thence along the South line of said prior deed reference S 56 56 51 W 511.00 feet to an iron pin (set) at the Southwest corner of said prior deed reference; thence along said West line N 30 52 27 W 59.35 feet to an iron pin (set); thence continuing along said West line N 28 22 27 W 226.00 feet to the place of beginning containing 3.043 acres.

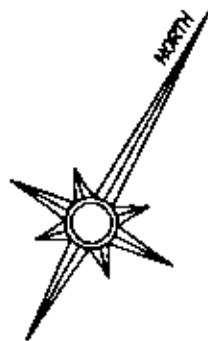

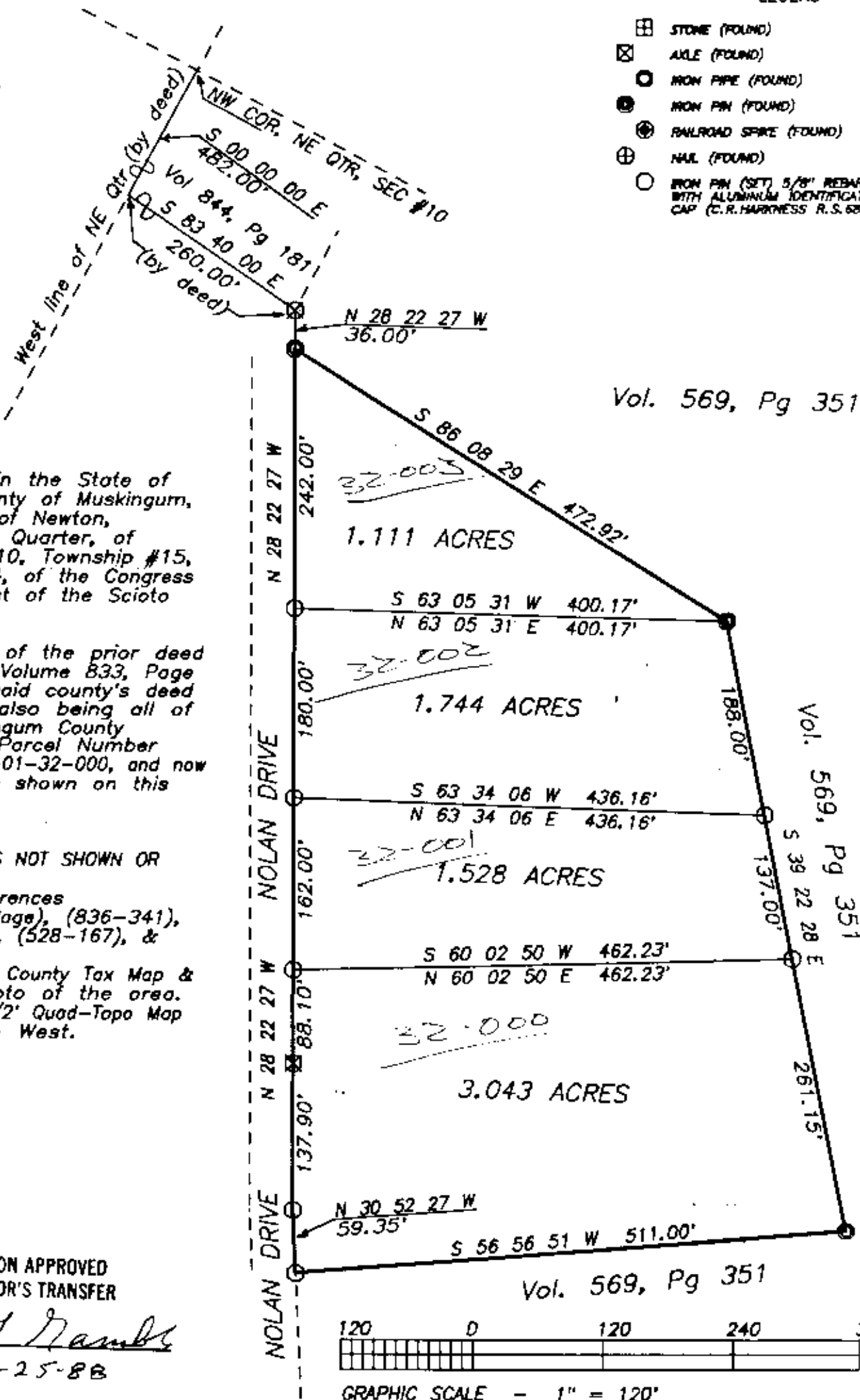
