

Survey for The Tyson Group

Being part of the northeast quarter of Section 10, Township 15 North, Range 14 West, Township of Newton, County of Muskingum, State of Ohio, and bounded and described as follows:

Commencing at the southeast corner of the northeast quarter of Section 10;
thence North 87 degrees 01 minutes 50 seconds West 938.66 feet;
thence along the east line of E.E. and P.J. McConnell (DR 471-562) North 01 degrees 21 minutes 10 seconds East 28.12 feet to an iron pin found;
thence continuing along the east line of E.E. and P.J. McConnell (DR 471-562) North 01 degrees 21 minutes 10 seconds East 309.55 feet to an iron pin set, the place of beginning for this parcel;

thence along the north line of E.E. and P.J. McConnell (DR 471-562) North 67 degrees 45 minutes 20 seconds West 172.85 feet to an iron pin found on the east line of the Trustees of Rolling Plains Methodist Church (DR 504-204);

thence along the east line of the Trustees of Rolling Plains Methodist Church (DR 504-204) North 10 degrees 11 minutes 40 seconds East 40.16 feet to an axle found;

thence along the east line of the Trustees of Rolling Plains Methodist Church (OR 1546-573) North 10 degrees 11 minutes 40 seconds East 95.36 feet to an iron pin found on the south line of the Board of County Commissioners of Muskingum County (OR 1658-463), also known as Panther Drive (50' wide);

thence along the south line of the Board of County Commissioners of Muskingum County (OR 1658-463), also known as Panther Drive (50' wide), on a curve to the left having a radius of 1229.19 feet, a delta angle of 03 degrees 29 minutes 14 seconds, a chord bearing and distance of South 68 degrees 43 minutes 30 seconds East 74.80 feet;

thence continuing along the south line of the Board of County Commissioners of Muskingum County (OR 1658-463), also known as Panther Drive (50' wide), South 70 degrees 28 minutes 10 seconds East 141.00 feet to an iron pin set;

thence leaving the south line of the Board of County Commissioners of Muskingum County (OR 1658-463), also known as Panther Drive (50' wide), South 28 degrees 07 minutes 56 seconds West 141.22 feet to the principal place of beginning, containing 0.60 acres, more or less.

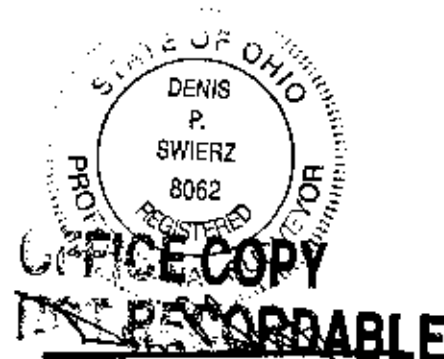
PLAT OF SURVEY FOR THE TYSON GROUP

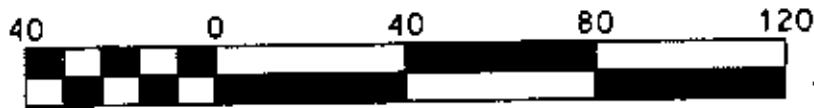
