DEED DESCRIPTION

Situated in the State of Chio, County of Ruskingum, Township of Newton, T-15, R-14, being a resurvey of Federal Mational Mortgage Assoc. Vol. 1781 Pg. 559, being part of the South Half of Section 10, and more particularly described as follows:

Beginning at a stone with an + at the Southeast Corner of the Southwest Quarter of Section 10; thence along the Mid Section Line North 03 Degrees 11 Minutes 20 Seconds Bast 637.61 feet to a point and the place of beginning; thence South 28 Degrees 22 Minutes 17 Seconds West 195.97 feet to an iron pin found; thence North 66 Degrees 50 Minutes 36 Seconds West 129.63 feet to an iron pin found; thence North 09 Degrees 02 Minutes 26 Seconds East 132.45 feet to an iron pin found; thence North 81 Degrees 47 Minutes 56 Seconds West 120.00 feet to a point, passing an axle found at 98.42 feet; thence North 03 Degrees 58 Minutes 34 Seconds Rest 48.63 feet to an iron pin found; thence South 55 Degrees 22 Minutes 30 Seconds Bast 31.00 feet to a mag. nail found in the centerline of Twp. Rd. 714 (Powell Drive); thence along said centerline North 39 Degrees 07 Minutes 30 Seconds East 122.10 feet to an iron pin found; thence South 67 Degrees 09 Minutes 20 Seconds East 109.94 feet to an iron pin found: thence South 60 Degrees 16 Minutes 37 Seconds East 142.68 feet to a 5/8" drill hole in a rock; thence South 28 Degrees 22 Minutes 17 Seconds West 43.95 feet to the place of beginning, containing 1.24 acres, more or less, subject to all legal highways and easements.


