DESCRIPTION OF SURVEY FOR HAYMOND & VERA NORMAN

Situated in the State of Ohio, County of Muskingum, Township of Newton, Southeast Quarter of Section #10, Township #15, Range #14 of the Congress Lands East of the Scioto River:

Being all of the property contained in the prior deed references Vol. 532, Page 805 & Vol. 548, Page 105 of the records of said County, Also being all of Muskingum County Auditor's Parcel Numbers #47-47-27-00-00-B03 & #47-47-29-03-51-000, and more particularly described as follows;

Commencing at an iron pipe (found) at the Southwest corner of Sonthern Hills IIII and of Lot #74 of same, as recorded in Plat Book 14, Page 101 of said County records; thence along the West line of said Southern Hills IIII N 0⁰ 08' 00" E 430.01 feet to an iron pin (set) at the place of beginning for the property herein intended to be described. passing an iron pin (found) at the West corner between Lots #71 & #72 of said Southern Hills IIII; thence N 71⁰ 55' 00" W 981.50 feet to an iron pin (set), passing the center of an existing drive used as Ingress-egress for the property at 958.12 feet; thence N 31° 03' 00" E 80.00 feet to an iron pin (set); thence N 47⁰ 20' 53" E 538.06 feet to an iron pin (set) at the most Westerly corner of Lot #60 of said Southern Hills IIII; thence along the line for said Southern Hills IIII S 64° 22' 37" E 551.41 feet to an iron pipe (found) at the Southeast corner of Lot #62 of said Sonthern Hills IIII; thence along the West line of said Southern Hills IIII S 0° 08' 00" W 499.30 feet to the place of beginning containing 9.158 acres.

The centerline of the above mentioned drive used for Ingress-egress is described as follows:


Beginning at the point mentloned in the above description and running along the center line the following twelve courses #1- \$ 79⁰ 25' 31" W 30.47 feet; #2~ N 56⁰ 15' 07" W 91.87 feet; #3- N 66⁰ 19' 33" W 33.29 feet; #4- N 51⁰ 05' 30" W 65.12 feet; #5- N 27⁰ 11' 23" W 29.90 foot; #6- N 55⁰ 24' 16" E 27.96 feet; #7- N 65⁰ 28' 53" E 52.67 feet; #8~ N 30⁰ 32' 19" E 69.02 feet; #9- N 01° 52' 44" W 35.72 feet; #10- N 38° 11' 57" W 19.51 feet; #11- N 72⁰ 20' 31" W 17.56 feet; #12- N 85⁰ 03' 32" W 50.56 feet to the center of Township Road #84 (Moxahala Place).

The bearings within this description are based on the West line of said Southern Hills IIII as shown on said Plat being N 0° 08' E. Iron pins (set) are 5/8" rebar 34" in length with aluminum identification caps (C R Harkness R S 6885).
