Situated in the State of Ohio, County of Muskingum, Township of Newton, T 15, R 14, part of the Northeast and part of the Northwest Quarters of Section 11, bounded and described as follows:

Commencing at the Northeast corner of the Northwest Quarter of Section 11; thence on section line South  $4^{\circ} 45'$  West 522.60 feet to a point; thence South  $42^{\circ} 07'$  West 529.32 feet to a point; thence South  $41^{\circ} 17'$  West 114.30 feet to a point in the center of Township Road 261, the place of beginning; thence South  $81^{\circ} 11'$  East along James Pandy 734.51 feet to an iron pin, passing an iron pin at 58.51 feet; thence South  $34^{\circ} 53'$  West along James Pandy 252.43 feet to an iron pin; thence North  $76^{\circ} 56'$  West along Gary McGee 765.23 feet to a point in center of Township Road 261, passing an iron pin at 732.23 feet; thence along center of Township Road 261 North  $48^{\circ} 13'$  East 220.00 feet to the place of beginning, containing 3.50 acres more or less. 1.42 acres in Northeast Quarter of Section 11 and 2.08 acres in Northwest Quarter of Section 11.

Basis of bearing is the East line of the Northwest Quarter of Section 11 bears South  $4^{\circ} 45'$  West.

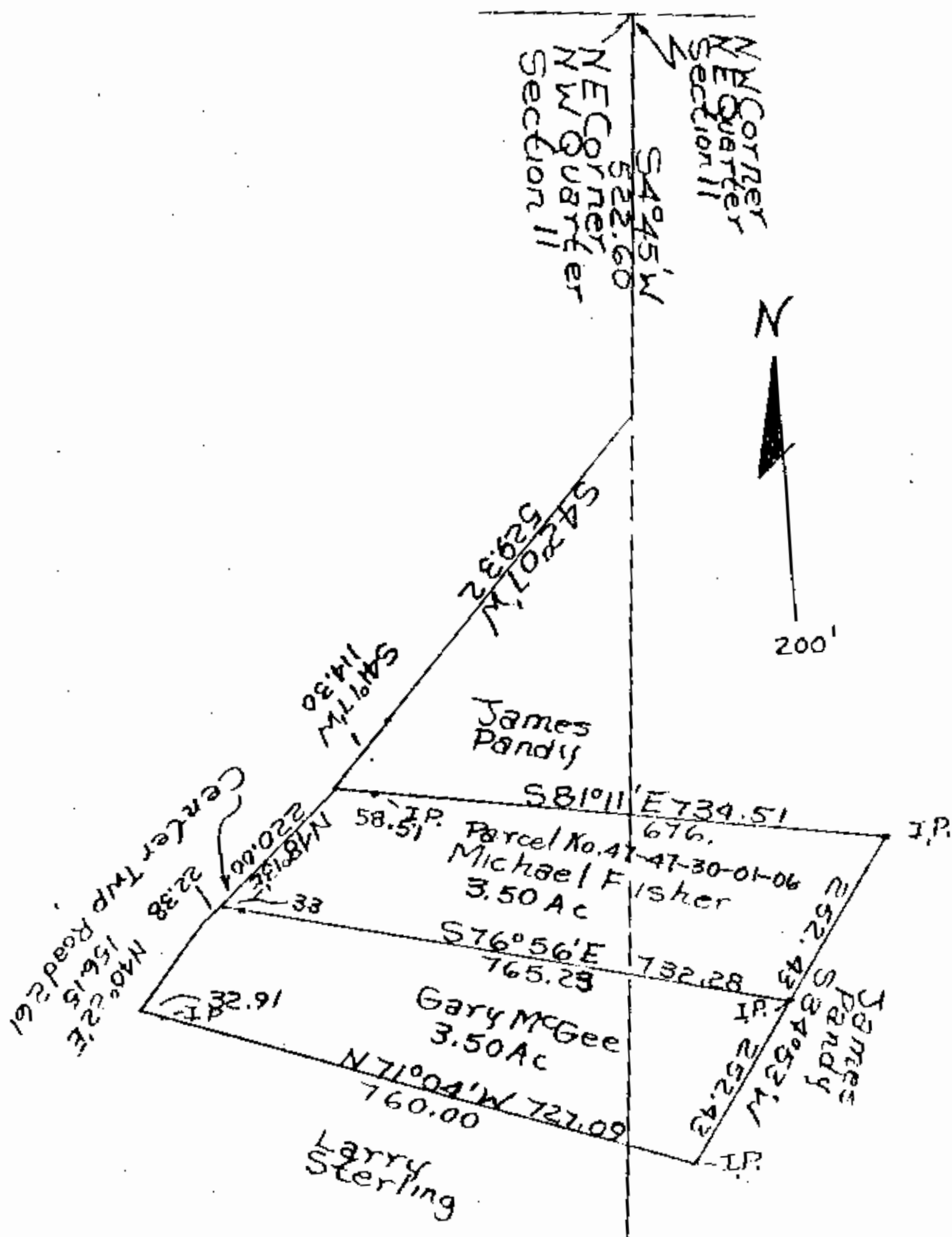
