- Beginning at an iron pin (set) at the center of Section 11;
- #1- **THENCE South 86 degrees 30 minutes 09 seconds East 1018.81 feet** along the common line for the Northeast and Southeast Quarters of Section 11 and common line for said Braydan Farms, LTD, for the Debra E Anderson and Nick B Anderson property recorded in Official Record Volume 2734, Page 458 for the Wayne E Anderson property recorded in Official Record Volume 2021, Page 767, and for the Lionel C McHenry and Latonia K McHenry property recorded in Official Record Volume 3168, Page 794 to an unmarked point in the center of Moxahala Creek, passing iron pins (set) at 760.06 feet and 939.07 feet;
