

Re-Survey of Danny L. and Lloyd E. Wiseman Lands

Situated in the State of Ohio, County of Muskingum, Township of Newton, and being part of the Southwest Quarter of Section 1, and the Northwest Quarter of Section 12, Township 15, Range 14, Congress Lands East of the Scioto River, and being all the lands presently owned by Danny L. and Lloyd E. Wiseman as per Official Record 2058, page 359, and being more particularly described as follows:

Beginning for reference at an iron pin found at the Southeast Corner of the Southwest Quarter of Section 1, Township 15, Range 14, Congress Lands East of the Scioto River;

Thence along the south line of Section 1, North 86 degrees 02 minutes 54 seconds West, 403.67 feet to a point on the southeast line of lands presently owned by Harlan Dobbins Jr.(DR 1018-16);

Thence along said Dobbins lands, South 33 degrees 00 minutes 55 seconds West, 49.56 feet to a iron pin set, on the most southern corner of said Dobbins lands, a angle point on the northwest line of lands presently owned by Zanesville M C Inc.(DR 612-21), the most eastern corner of lands presently owned by Danny Lco, and Lloyd Eugene Wiseman, (OR 2058-359) and the principal place of beginning;

Thence along the northwest line of said Zanesville M C Inc. lands, South 42 degrees 03 minutes 22 seconds West, 1137.37 feet to an iron pin found on the southeast corner of lands presently owned by B. Watson,(OR 1882-647);

Thence along the east line of said Watson lands, and the east line of lands presently owned by R. M. and T. M. Brennan,(OR 2301-50), North 51 degrees 31 minutes 28 seconds West, 781.89 feet to an iron pipe found on the southwest corner of lands presently owned by B. E. Lane,(OR 2071-436, passing an iron pin found at 287.88 feet;

Thence continuing along said Lane lands the following two courses:

- 1.) North 38 degrees 31 minutes 50 seconds East, 103.90 feet to an iron pipe found;
- 2.) North 51 degrees 29 seconds 24 seconds West, 414.25 feet to the centerline of Darlington Road, passing an iron pin set at 393.25 feet;

Thence along the centerline of Darlington Road the following five courses:

- 1.) North 41 degrees 09 minutes 44 seconds East, 219.29 feet to a point;
- 2.) North 41 degrees 39 minutes 24 seconds East, 577.55 feet to a point;
- 3.) North 42 degrees 09 minutes 34 seconds East, 106.74 feet to a point;
- 4.) North 43 degrees 23 minutes 27 seconds East, 84.83 feet to a point;
- 5.) North 45 degrees 40 minutes 24 seconds East, 92.08 feet to a point on the south line of lands presently owned by L. E. Wiseman, (OR 2210-494);

Thence along the south line of said Wiseman lands and the south line of lands presently owned by H. Dobbins Jr.(DR 1018-16), South 49 degrees 16 minutes 31 seconds East, 1200.00 feet to the principal place of beginning, passing an iron pin found at 19.00 feet, and an iron pipe found at 467.10 feet, containing 31.11 acres, more or less.

Subject to all legal recorded easements and right of ways.

Bearings are based on the south line of the Southwest Quarter of Section 1, as being North 86 degrees 02 minutes 54 seconds West, as per previous survey C. Harkness.

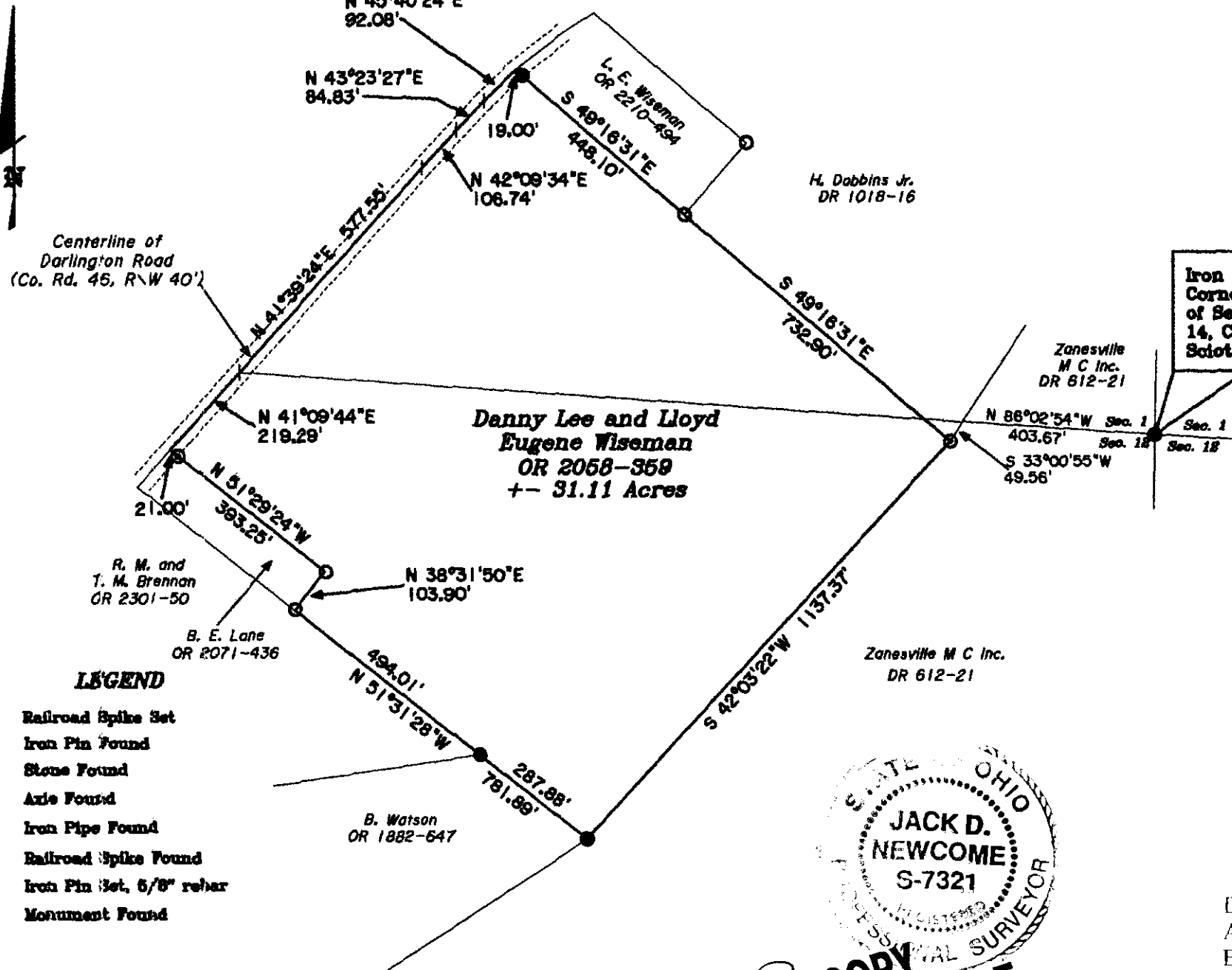

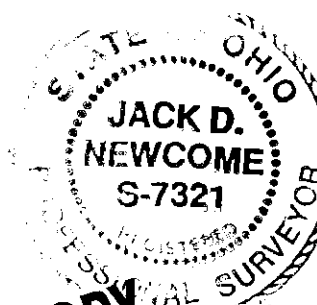
