Commencing at an iron pin (found capped 7224) at the common corner for Sections 23, 24, 25, and 26 of Newton Township and said Township and Range;

- TIE- THENCE North 03 degrees 26 minutes 54 seconds East 1891.93 feet along the common line for Sections 23 and 24, and through the Chesterhill Stone Company property (Now Shelly Materials, Inc) recorded in Deed Book Volume 1058, Page 593 to an unmarked point in the centerline of Maysville Pike (US Route 22) and the place of beginning for the property herein intended to be described;
- #1- THENCE South 84 degrees 08 minutes 08 seconds West 221.63 feet along the chord of a curve to the left having, a radius of 3819.49 feet, and arc length of 221.66 feet into Section 23 and along said US 22, further being a common line for said Campbell and Chesterhill Stone Company properties to the unmarked Southeast corner of the Robert James Hammer property recorded in Official Record Volume 2252, Page 947;
- #2- THENCE North 03 degrees 12 minutes 21 seconds East 389.25 feet leaving said road and along the common line for said Campbell and Hammer properties to an unmarked point in the centerline of Old Town Road (County Road 652), passing an iron pipe (found disturbed) at 52.95 feet and iron pin (found capped 6885) at 359.25 feet;
- #3- THENCE North 70 degrees 45 minutes 56 seconds East 104.41 feet along the centerline of Old Town Road and common line for said Campbell property and for the Michael D Kirkbride and Cynthia A Kirkbride property recorded in Official Record Volume 2817, Page 707 to an unmarked corner of the Dillon Allen Baker property recorded in Official Record Volume 2999, Page 169;
- #4- THENCE South 18 degrees 18 minutes 57 seconds East 157.55 feet leaving said road and along a common line for said Campbell and Baker properties to an iron pipe (found), passing an axle (found) at 33.01 feet;
- #5- THENCE North 70 degrees 57 minutes 37 seconds East 71.00 feet continuing along said properties to an iron pin (set) on the common line for Sections 23 and 24:
- #6- THENCE South 03 degrees 26 minutes 54 seconds West 274.49 feet along said Section line and crossing said Campbell property to the place of beginning, passing an iron pin set at 226.08 feet, containing 1.73 acres, of which 0.24 acres are within the right of way for Maysville Pike (US 22) and 0.08 acres within the right of way for Old Town Road (County Road 652).
