

DESCRIPTION OF SURVEY FOR NEWTON TOWNSHIP TRUSTEES

Situated in the State of Ohio, County of Muskingum, Township of Newton:

Being part of Section #17, Township #15, Range #14, of the Congress Lands East of the Scioto River, being part of the Earl & Charlotte Henry property as described in deed reference Deed Book Volume 570, Page 544, being all of the remaining portion of Lot #27 of the Village of Newtonville (Now Known as White Cottage), as recorded in Plat Book "X", Page 233 being all of Muskingum County Auditor's Parcel Number 47-42-02-29-000, and more particularly described as follows;

- Beginning at an iron pin (found) at the Eastern corner of said Lot #27 being on the West side of Limestone Valley Road (County Road #652) previously known as Maysville Pike;
- #1- thence S 51 13 00 W 20.00 feet along the West side of said road and Southeast line of said Lot #27 to an iron pin (set) 46.00 feet from the Southern corner of said Lot #27 and at the Eastern corner of the Jan Stoneburner property as described in deed reference Deed Book Volume 1038, Page 97;
 - #2- thence N 38 47 00 W 132.00 feet through said Lot #27 and along a line of said Stoneburner property to an iron pin (set) on the Northwest line of said Lot #27 and Northern corner of said Stoneburner property and on a line of the Public Square of said village plat, also being 46.00 feet from the Western corner of said Lot #27;
 - #3- thence N 51 13 00 E 20.00 feet along the Northwest line of said Lot #27 and a line of said Public Square to an iron pin (found) at the Northern corner of said Lot #27;
 - #4- thence S 38 47 00 E 132.00 feet along the common line for said Lot #27 and Lot #26 also of said village plat to the place of beginning containing 0.06 acres.

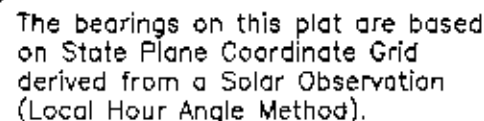
The bearings within the description are based on State Plane Coordinate Grid derived from a Solar Observation (Local Hour Angle Method). Bearings are shown in a format of Degrees, Minutes, and Seconds. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.#6885).

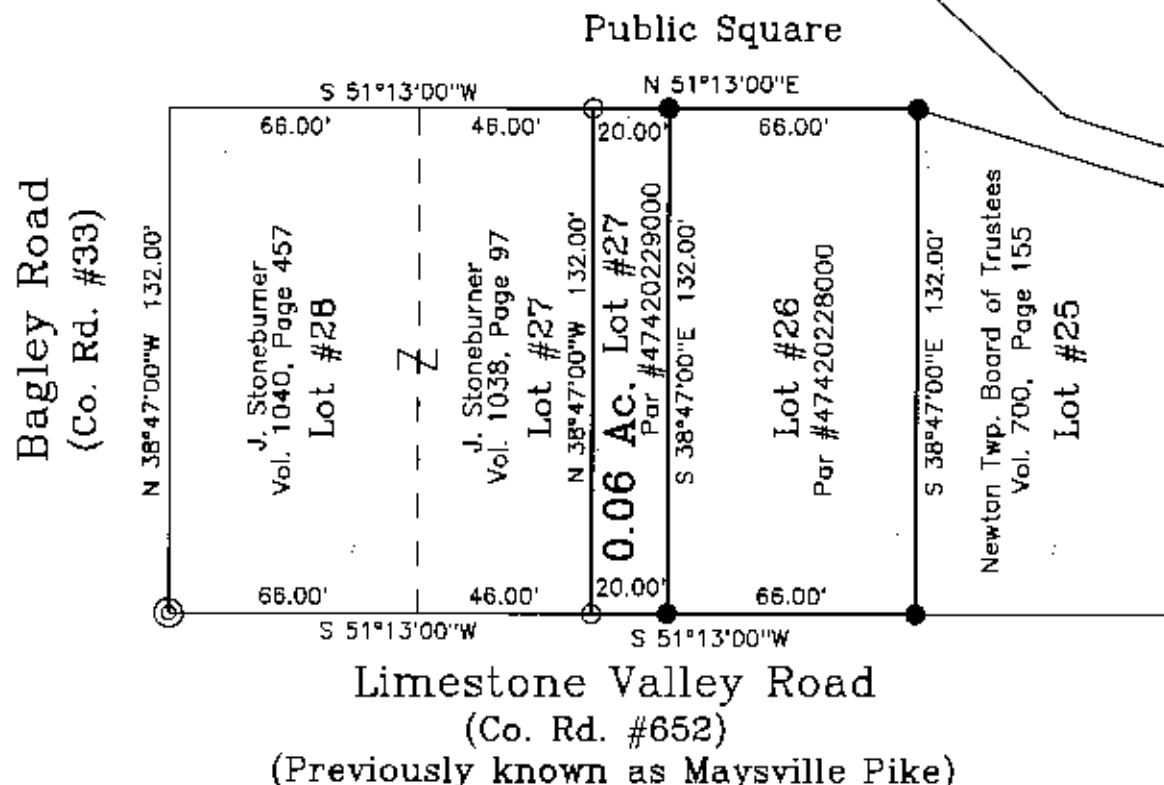

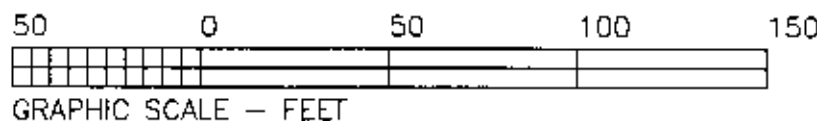
