

DESCRIPTION OF SURVEY FOR JOAN E PATTON ESTATE

Situated in the State of Ohio, County of Muskingum, Township of Newton;

Being part of the Northeast and Northwest Quarters of Section #17, of Township #15, Range #14, of the Congress Lands East of the Scioto River, **being all of** Parcels Two and Three of Tract Four of the Joan E Patton property recorded in Official Record Volume 1502, Page 742 of said county's deed records, further being all of Muskingum County Auditor's Parcel Numbers **47-42-05-12-000 and 47-42-05-23-000**, and more particularly described as follows;


Beginning at an iron pin (set) at the Western corner of Lot #2 of Gladstone's Addition recorded in Plat Book 3, Page 2;

- #1- THENCE North 63 degrees 20 minutes 25 seconds West 260.68 feet** along the North line of Orchard Street, crossing into the Northwest Quarter of Section #17 to an unmarked point in the centerline of Limestone Valley Road (County Road #652), passing an iron pin (set) at 220.68 feet;
- #2- THENCE North 49 degrees 22 minutes 30 seconds East 225.74 feet** along Limestone Valley Road to an unmarked point in the bridge crossing Kent's Run;
- #3- THENCE South 55 degrees 49 minutes 55 seconds East 175.01 feet** leaving said road, along Kent's Run, crossing into said Northeast Quarter of Section #17, and along the common line for said Patton property and for the John Danielson property recorded in Deed Book Volume 1129, Page 42 and Leona L Bradley property recorded in Official Record Volume 2058, Page 398 to the unmarked Northern corner of said Lot #2;
- #4- THENCE South 26 degrees 39 minutes 35 seconds West 185.36 feet** leaving Kent's Run, and along said Lot #2 to the place of beginning, passing an iron pin (set) at 44.37 feet, **containing 0.99 acres**, of which 0.18 acres are within the right of way for Limestone Valley Road (County Road #652).


The bearings within this description are based on State Plane Coordinate Grid (Ohio South 1983) derived from GPS Observations. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.6885).


