- #19- THENCE North 46 degrees 35 minutes 12 seconds East 67.96 feet along the chord of a curve to the left having, a radius of 1293.21 feet, and arc length of 67.97 feet continuing along said abandoned railroad and T&T Thompson parcels to an iron pin (set);**
- #20- THENCE North 44 degrees 53 minutes 08 seconds East 220.62 feet** continuing along said abandoned railroad and T&T Thompson parcels to an iron pin (set);
