Situated in the State of Ohio, County of Muskingum, Township of Newton, Township 15, Range 14, Section 15, bounded and described as follows:

Commencing at a stone found at the Northwest corner of Lot 22 of the Village of Avondale; Thence North $89^{\circ}58'52''$ East 346.84 feet to a stone at the Northeast corner of Lot 30 of Avondale; Thence South $89^{\circ}58'54''$ East 519.26 feet to a point; Thence North $0^{\circ}00'00''$ East 50.00 feet to a point; Thence North $90^{\circ}00'00''$ East 45.22 feet to a point; Thence North $0^{\circ}47'25''$ East 549.23 feet to an iron pin; Thence on a 40 foot radius curve to the left the chord of which bears North $44^{\circ}48'44''$ West 57.16 feet to an iron pin; Thence South $89^{\circ}35'07''$ West 80.32 feet to an iron pin the place of beginning; Thence South $0^{\circ}47'25''$ West 111.40 feet to an iron pin; Thence North $89^{\circ}45'21''$ West 120.24 feet to an iron pin on the East side of Valley Street (30.00 feet wide); Thence along said street North $0^{\circ}14'39''$ East 70.46 feet to an iron pin; Thence on a 40.00 foot radius curve to the right the chord of which bears North $44^{\circ}54'53''$ East 56.24 feet to an iron pin on the South Line of Browning Drive; Thence along Browning Drive North $89^{\circ}35'07''$ East 81.77 feet to the place of beginning containing 0.300 acres more or less: Being Lot No. 9 Unrecorded Browning Subdivision;

Bearings are based on the line from Lot 22-30 of Village of Avondale being North $89^{\circ}58'52''$ East.

Being part of Auditor's Parcel Number 47-50-15-08-000.

Iron pins set are No. 5 reinf. bars 30 inches long with plastic ID caps.




