

**Dayle Browning****Lot 12**

Situated in the State of Ohio, County of Muskingum, Township of Newton, Township 15, Range 14, Section 15, bounded and described as follows:  
*Being a part of Vol. 967, Pg. 162. Parcel No. 47-50-15-08-000*  
 Commencing at a stone found at the Northwest corner of the Northeast quarter of Section 15; Thence South  $20^{\circ}28'23''$  East 365.15 feet to a point in the South line of Roadale Drive; Thence North  $89^{\circ}54'27''$  East 69.85 feet to a point; Thence North  $84^{\circ}33'43''$  East 17.17 feet to an iron pin on the Northwest corner of Lot 12 the place of beginning; Thence continuing along Roadale Drive on a 90.0 foot radius curve to the left chord of which bears North  $62^{\circ}01'05''$  East 52.45 feet to an iron pin; Thence leaving Roadale Drive and along Lot 11 South  $40^{\circ}55'51''$  East 231.06 feet to an iron pin; Thence North  $89^{\circ}55'00''$  West 160.00 feet along the center of the vacated part of Lane "A" of the Village of Avondale to an iron pin; Thence North  $00^{\circ}05'00''$  East 7.50 feet along the end of the vacated part of Lane "A" to an iron pin; Thence North  $89^{\circ}55'00''$  West 37.45 feet to an iron pin at the corner of Lot 13; Thence along Lot 13 North  $00^{\circ}05'33''$  West 142.17 feet to the place of beginning containing 0.465 Acres more or less.

Bearings are based on the North line of the Northeast quarter of Section 15 bearing North  $89^{\circ}35'07''$  East.

Iron pins set are No. 5 reinforced bars 30 inches long with plastic ID caps.

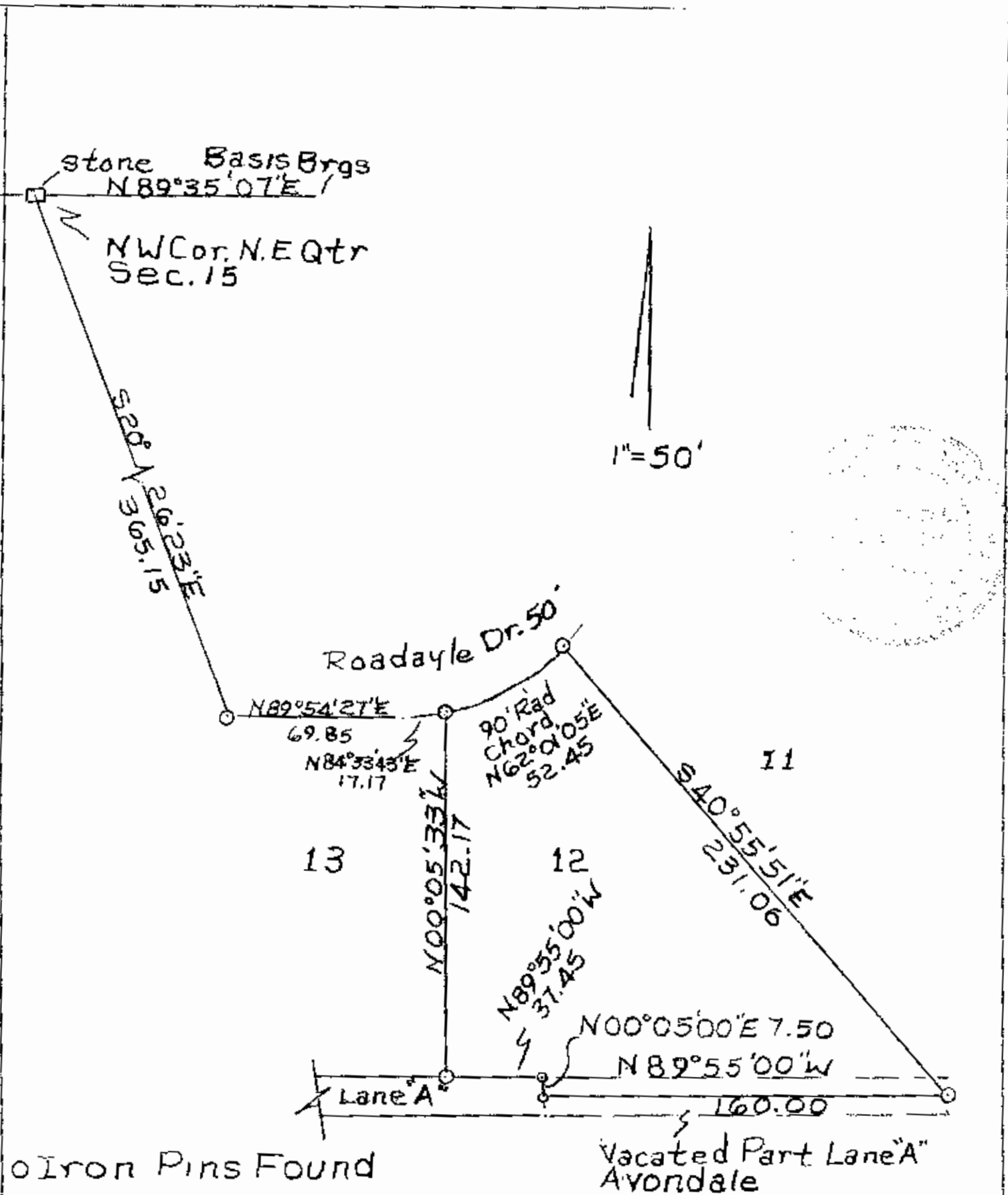
