Being a part of the Southwest Quarter of Section Fifteen (15), Township Fifteen (15), Range Fourteen (14) of the Congress Lands East of the Scioto River and part of property now owned by John C. and Susan M. Roberts and Recorded in Deed Book 1020, Page 115 of the Muskingum County Deed Records bounded and described as follows:

Commencing at a post at the southwest corner of said southwest quarter of section 15; thence N.2°10'45"E. (the base of bearings for this description state plane grid from a solar observation) along the west line of said southwest quarter 550.00' to a concrete copperweld monument found at the true place of beginning for the following described property; thence continuing N.2°10'45"E. along the west line of said southwest quarter of section 15 a distance of 351.89' to an iron pin set; thence along the south line of a 6.534 acre parcel owned by said John C. and Susan M. Route 93 at 42.91'; thence N. $3^{\circ}12'21''$ E. along the east line of
said Ohio Power Property 100.00' and passing through a concrete
monument found at 2.83'; thence N. $54^{\circ}28'05''$ W. 841.37' to the true
place of beginning containing sixty four and sixteen hundredths
(64.16) acres more or less of which 2.10 acres is under
easement for State Route 93 and 2.07 acres of said easement is
limited access.
