

DESCRIPTION OF SURVEY FOR J & G MALFE

JOB#1265-2

Situated in the State of Ohio, County of Muskingum, Township of Newton:

Being part of Southeast Quarter, of Section #15, Township #15, Range #14, of the Congress Lands East of the Scioto River, **being part of the J & G Malfe** property recorded in Deed Book Volume 607, Page 298 of said county's deed records, known as Muskingum County Auditor's **Parcel Number 47-50-15-41-000** and more particularly described as follows;

Commencing at an iron pin (found) at the intersection of the East Right of Way for Moxahala Avenue as shown on the Plat of Avondale recorded in Plat Book 4, Pages 72 and 140 of said county's plat records, and the common line for the Northeast and Southeast Quarters of said Section #15, also being on the North line of a 10 foot wide access included in the B White property recorded in Deed Book Volume 1104, Page 445; **THENCE South 04 degrees 45 minutes 00 seconds West 10.00 feet** into said Southeast Quarter of Section #15 and crossing said 10 foot wide access to an unmarked point on the North line of said Malfe property; **THENCE South 85 degrees 15 minutes 00 seconds East 539.68 feet** along a common line for said Malfe and White properties and South line of said 10 foot wide access to an iron pin (found) at the Northeast corner of said Malfe property; **THENCE South 03 degrees 42 minutes 45 seconds West 249.99 feet** leaving said 10 foot wide access and continuing along a common line for said Malfe and White properties to an iron pin (set) at the place of beginning for the property herein intended to be described;

- #1- THENCE South 03 degrees 42 minutes 45 seconds West 240.66 feet** continuing along a common line for said Malfe and White properties to an iron pin (found) at the Southeast corner of said Malfe property being on the North right of way for the C & M V Railroad;
- #2- THENCE North 70 degrees 26 minutes 35 seconds West 212.02 feet** along the common line for said Malfe property and railroad to an iron pin (set);
- #3- THENCE North 03 degrees 42 minutes 45 seconds East 186.47 feet** through said Malfe property to an iron pin (set);
- #4- THENCE South 85 degrees 15 minutes 00 seconds East 204.00 feet** continuing through said Malfe property to the place of beginning, passing an iron pin (set) at 184.00 feet, **containing 1.00 acres.**

ALSO EASEMENT GRANTED AND EASEMENT SAVED AND EXCEPTED

Also granted a non exclusive 10 foot wide ingress and egress easement along the North line of said Malfe property, running from Butler Road (Township Road #84) to the East line of said Malfe property, adjoining a 10 foot wide private access described in Deed Book Volume 607, Page 298, for a total of 20 feet in width.

Also granted a non exclusive 20 foot wide ingress and egress easement along the East line of said Malfe property, running from North line of Malfe property to the North line of the above described 1.00 acre parcel.

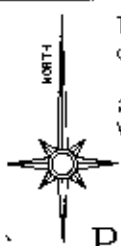
The expressed intent of the granted easements is to widen the existing private access, provide access to the above described 1.00 acre parcel, and provide access to a 1.17 acre parcel also surveyed from said Malfe property located North of the above described 1.00 acre parcel. This access does not meet public road right of way specifications and is not intended to become a public road. Maintenance is to be the sole responsibility of property owners with interest in the existing and widened private access.

The bearings within this description are based on the North line of the J & G Malfe property recorded in Deed Book 607, Page 298. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.6885).

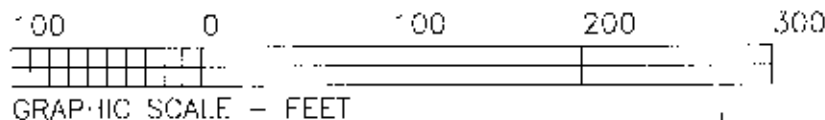
