Commencing at an iron pin at the Northeast Corner of the Southeast Quarter of Section 15; Thence South $69^{\circ}52'36''$ West 1092.68 feet to an iron pin set the place of beginning; Thence South $1^{\circ}06'28''$ West 261.03 feet to a point on the North line of Old C.&M.V. Rail Road Right of Way; Thence along the North line of rail road the next three courses and distances: North $73^{\circ}06'01''$ West 216.09 feet to a point, South $16^{\circ}53'59''$ West 10.00 feet to a point, and North $73^{\circ}06'01''$ West 213.23 feet to a point; Thence leaving rail road and along the split lines of Belva White, North $1^{\circ}06'28''$ East 165.46 feet to an iron pin set and South $87^{\circ}17'17''$ East 416.00 feet to the place of beginning containing 2.035 acres more or less.

Parcel 2:

Commencing at the Northeast Corner of the Southeast Quarter of Section 15; Thence South $69^{\circ}52'36''$ West 1092.68 feet to an iron pin; Thence South $1^{\circ}06'28''$ West 354.56 feet to a point on the South line of Old C. & M. V. Rail Road the place of beginning; Thence leaving rail road and along the split lines of Belva White the next three courses and distances: South $1^{\circ}06'28''$ West 22.09 feet to an iron pin set, North $87^{\circ}17'42''$ West 416.00 feet to an iron pin set, and North $1^{\circ}06'28''$ East 138.49 feet to a point on the South line of said rail road; Thence along the South line of said rail road the next three courses and distances: South $73^{\circ}06'01''$ East 193.43 feet to a point, South $16^{\circ}53'59''$ West 10.00 feet to a point, and South $73^{\circ}06'01''$ East 241.54 feet to the place of beginning containing 0.761 acres more or less.

Also a 15 foot right of way from the center of North line of First Parcel North $2^{\circ}42'43''$ East 24.05 feet to the North line of Belva White, and along the North line of Belva White North $87^{\circ}17'17''$ West 577.45 feet to an iron pin at Belva Whites Northwest Corner, and on a 10.00 foot wide right of way along Jim Malfe North $87^{\circ}35'19''$ West 579.84 feet to the intersection of the center of Moxahala Ave. of the Village of Avondale.

Bearings are based on the North line of Belva White bearing North $87^{\circ}17'17''$ West.

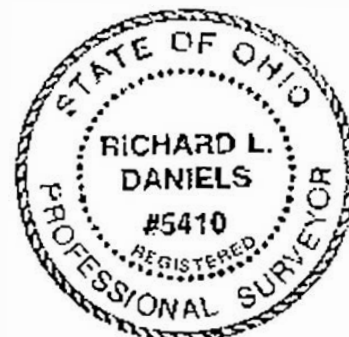
