DEED DESCRIPTION

Situated in the State of Ohio, County of Muskingum, Township of Newton, T-15, R-14, being a part of R. Fraunfelter V 522 P 898, being part of the North Half of Section 23, and more particularly described as follows:

Beginning at an axle found at the Northwest Corner of the Northeast Quarter of Section 23; thence along the North line of Section 23 South 89 Degrees 33 Minutes 36 Seconds East 2526.43 feet to a point in the centerline of County Road 46, passing an iron pipe found at 2486.17 feet; thence along said centerline South 50 Degrees 19 Minutes 19 Seconds East 245.69 feet to a point in said centerline; thence leaving said road along the East line of Section 23 South 00 Degrees 16 Minutes 25 Seconds East 1197.58 feet to a point in a pond, passing an iron pin set at 877.24 feet; thence South 89 Degrees 20 Minutes 19 Seconds West 1353.00 feet to an iron pin set, passing an iron pin set at 100.00 feet; thence North 00 Degrees 16 Minutes 14 Seconds West 332.25 feet to an iron pin set; thence North 87 Degrees 49 Minutes 52 Seconds West 696.12 feet to an iron pin set; thence South 00 Degrees 15 Minutes 10 Seconds West 1650.00 feet to an iron pin set; thence North 89 Degrees 42 Minutes 38 Seconds West 660.00 feet to an iron pin set; thence North 00 Degrees 10 Minutes 31 Seconds East 326.70 feet to an iron pin set; thence North 89 Degrees 49 Minutes 29 an iron pin set; thence North 89 Degrees 49 Minutes 29 Seconds West 377.00 feet to an iron pin set in the centerline of Township Road 89; thence along said road the following 7 courses to points: North 16 Degrees 09 Minutes 39 Seconds West 296.24 feet; thence North 00 Degrees 32 Minutes 37 Seconds West 117.26 feet; thence North 08 Degrees 21 Minutes \06 Seconds East 183.88 feet; thence North 05 Degrees 09 Minutes 19 Seconds West 197.59 feet; thence North 11 Degrees 30 Minutes 54 Seconds West 182.89 thence North 11 Degrees 30 Minutes 54 Seconds West 182.89 feet; thence North 01 Degrees 59 Minutes 01 Seconds West 166.12 feet; thence North 24 Degrees 58 Minutes 35 Seconds West 143.72 feet; thence leaving said road South 89 Degrees 19 Minutes 26 Seconds East 223.33 feet to an iron pin found; thence North 68 Degrees 09 Minutes 04 Seconds East 109.92 feet to an iron pin found; thence North 01 Degrees 16 Minutes 50 Seconds West 179.66 feet to an iron pin found; thence North 77 Degrees 25 Minutes 14 Seconds East 243.76 feet to an axle found; thence North 00 Degrees 39 Minutes 35 Seconds West 822.73 feet the place of beginning, containing 113.93 acres, more or less, subject to all legal highways and easements.

Subject to a 10 foot easement for ingress & egress as recorded in V 162 P 453, being 10 feet wide along the entire most southerly line of 660.00 feet as described above.
