Situated in the State of Ohio, County of Muskingum, Township of Newton, Township 15, Range 14, Section 13, bounded and described as follows:

Being part of Arvilla Mahan Vol. 626, Page 25, Parcel No. 47-52-13-09-000.

Commencing at a stone found at the Southeast Corner of Northwest Quarter of Section 13; Thence North $84^{\circ}57'40''$ West 1413.96 feet to an iron pin; Thence North $5^{\circ}16'03''$ East 617.26 feet to an iron pin set the place of beginning; Thence North $5^{\circ}16'03''$ East along Parcel No. 47-52-13-08-000, 119.00 feet to an iron pipe found; Thence along Alan Mahon Parcel No. 47-52-13-09-002 North $43^{\circ}35'47''$ East 471.95 feet to an iron pin set; Thence continuing along Alan Mahon North $53^{\circ}16'57''$ West 168.87 feet to a point in center of Mahon Road; Thence along the center of Mahon Road and the South line of P. Kelley Vol. 1123, Page 222 the next three courses and distances: North $87^{\circ}42'19''$ East 5.33 feet to an iron pin found, North $72^{\circ}32'29''$ East 155.70 feet to an iron pin found, and North $62^{\circ}22'53''$ East 117.69 feet to a point; Thence along the split lines of Arvilla Mahon the next 4 courses and distances: South $34^{\circ}09'27''$ East 262.66 feet to an iron pin set passing an iron pin set at 12.58 feet, South $17^{\circ}55'47''$ West 121.32 feet to an iron pin set, South $51^{\circ}31'28''$ West 238.94 feet to an iron pin set and South $64^{\circ}37'21''$ West 423.03 feet to an iron pin set the place of beginning containing 3.82 acres more or less:

Bearings are based on the West line of the Northwest Quarter of Section 13 bearing North $5^{\circ}15'30''$ West.

Iron pins set are No. 5 reinf. bars 30 inches long with plastic ID caps.

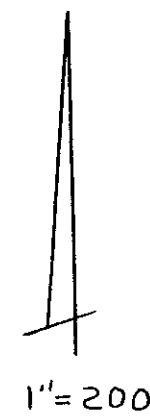
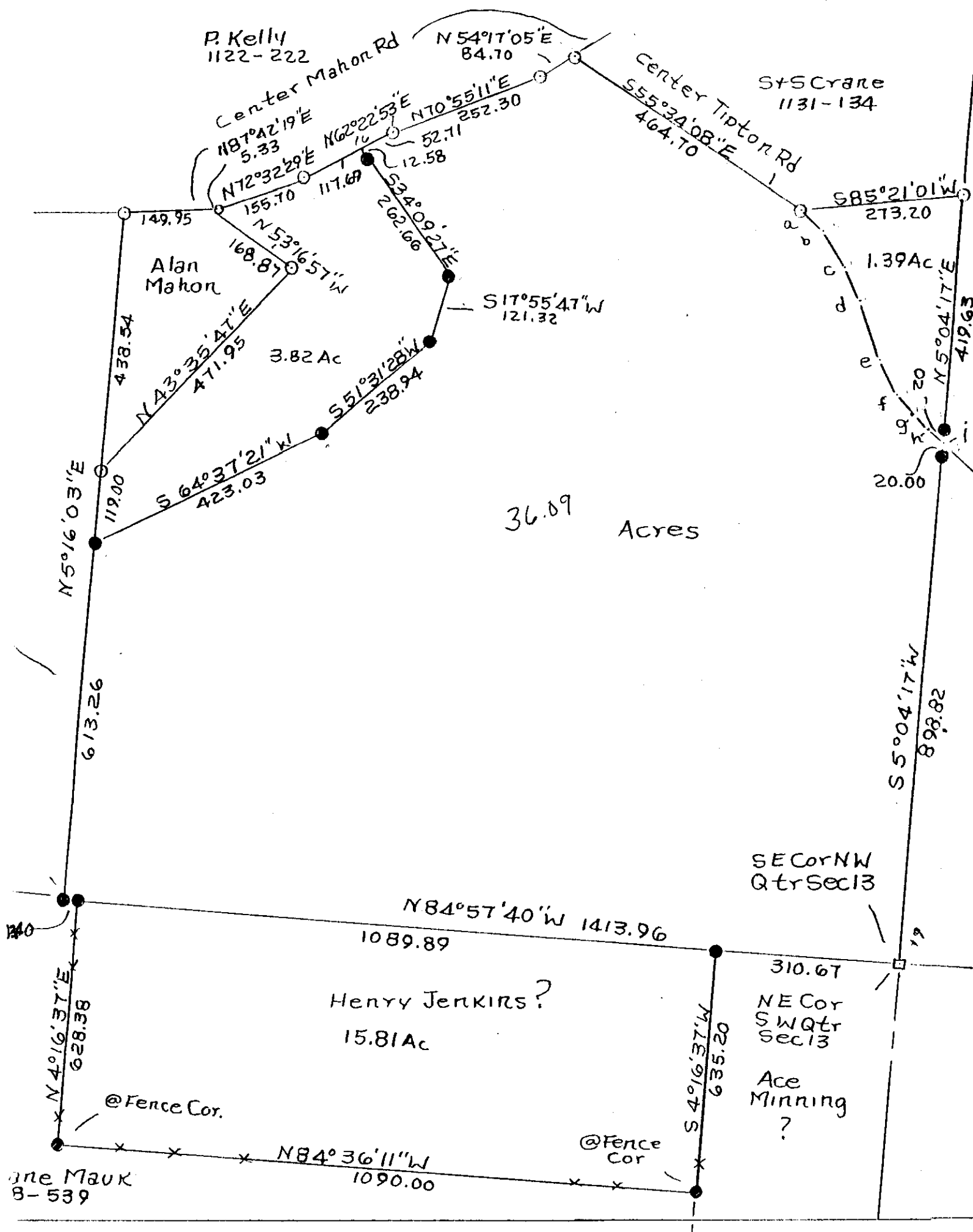
