Situated in the State of Ohio, County of Muskingum, Township of Newton.

Being a part of the northeast quarter of Section 24, Quarter Township 4, Township 15, Range 14 bounded and described as follows:

Beginning at an iron pin found at the northwest corner of the northeast guarter of Section 24; thence along the north line of Section 24 south 87 degrees 59 minutes 45 seconds east 1376.71 feet to a point passing an iron pin found at 1138.80 feet; thence south 3 degrees 09 minutes 44 seconds west 1830.88 feet to a railroad spike set in the center of Restless Road passing an iron pin placed at 1792.88 feet; thence along the center of Restless Road the following eight (8) courses and distances south 73 degrees 37 minutes 02 seconds west 84.49 feet to a point; thence south 88 degrees 53 minutes 09 seconds west 101.44 feet to a point; thence north 84 degrees 25 minutes 20 seconds west 242.19 feet to a point; thence on a curve to the right having a radius of 700 feet an arc length of 364.34 feet (the chord of which bears north 69 degrees 30 minutes 41 seconds west 360.25 feet) to a point; thence north 54 degrees 36 minutes 01 seconds west 346.47 feet to a point; thence on a curve to the right having a radius of 323.95 feet an arc length of 171.32 feet (the chord of which bears north 39 degrees 26 minutes 58 seconds west 169.33 feet) to a point; thence north 24 degrees 17 minutes 55 seconds west 98.47 feet to a point; thence on a curve to the left having a radius of 240.71 feet an arc length of 191.13 feet (the chord of which bears north 47 degrees 02 minutes 44 seconds west 186.15) to a railroad spike set; thence north 2 degrees 30 minutes 50 seconds east 93.29 feet to an iron pin set; thence south 87 degrees 29 minutes 10 seconds east 82.50 feet iron pin set; thence north 2 degrees 30 minutes 50 seconds east 264.0 feet to an iron pin set; thence north 87 degrees 29 minutes 10 seconds west 82.50 feet to a stone found; thence north 2 degrees 30 minutes 50 seconds east 848.23 feet to the place of beginning, containing fiftytwo and forty-four hundredths (52.44) acres more or less.
