## **Description of a 0.337 Acre Parcel**

BEGINNING at the northeast corner of the Southeast Quarter of said Section 24; Thence along the easterly line of the Southeast Quarter of said Section 24, South 03°41'37" West, a distance of 134.95 feet to a 5/8" iron rebar stamped "5792" found at the southeast corner of a parcel conveyed to Kathy Leigh Combs in OR Bk. 1561, Pg. 856 of said County Records; Thence along the southerly line of said Combs parcel, South 74°00'35" West, a distance of 859.15 feet to a 1" pinch top iron pipe found at the southwest corner of said Combs parcel, and passing on line a 5/8" iron rebar stamped "5792" found at 92.32 feet; Thence along the westerly line of said Combs parcel, North 22°26'33" West, a distance of 549.14 feet to the southwest corner of a parcel conveyed to Daniel C. Hiles and Marsha K Hiles in Deed Bk. 998, Pg. 240 of said County Records, and passing on line a 5/8" iron rebar stamped "5792" found at 404.99 feet and a 5/8" iron rebar stamped "5792" found at 538.96 feet; Thence along the southerly line of said Hiles Parcel, North 63°20'30" East, a distance of 71.23 feet to a "5451" capped iron pin found at the southeast corner of said Hiles parcel and the TRUE POINT OF BEGINNING of the parcel herein described;

Course No. 1; Thence along the easterly line of said Hiles parcel, North 21°15'43" West, a distance of 146.06 feet to the centerline of Old Town Road (County Road 652, formerly State Route 22, 60' Wide), and passing on line a "5451" capped iron pin found at 116.10 feet;

Course No. 2; Thence 110.79 feet along the arc of a non-tangent curve to the right, said curve having a radius of 955.37 feet, a delta of 06°38'40", being subtended by a chord bearing North 76°53'31" East, a chord length of 110.73 feet to the northwest corner of a parcel conveyed to James P. Stoneburner and Barbara Ann Stoneburner in Or Bk. 2454, Pg. 50 of said County Records;

Course No. 3; Thence along the westerly line of said Stoneburner parcel, South 21°15'43" East, a distance of 120.00 feet to a bent axle iron found on the northerly line of said Combs parcel, and passing on line a 3/4" iron pipe found at 26.09 feet;
