Situated in the Northwest Quarter of section 19, T-15, R-14, Newton Township, Muskingum County, Ohio. Being part of the lands of Dale and Betty Clayton conveyed in Deed Books 651 page 95 and Book 923 page 198 and all the lands conveyed in Deed Book 966 page 239, parcel 2 of the Muskingum County Deed Records and being described as follows:

Commencing at the Southwest corner of the Northwest quarter of section 19; thence, N.02°41'49"W. a distance of 654.39 along the west line of said quarter section to a point in the center of Old Town Road (formerly U.S. 22), and BEING THE POINT OF BEGINNING;

Thence, N.02°41'49"W. a distance of 121.74 feet along the West line of Said quarter section to a set rebar;

Thence, S.77°45'25"E. a distance of 144.43 feet through the lands of D. & B. Clayton (651/95, 923/198) to a set rebar;

Thence, S.32°40'38"W. a distance of 96.54 feet through said Clayton lands to a point in the center of Old Town Road, passing a set rebar at 62.88';

Thence, on a curve to the left an arc distance of 84.02', with a radius of 388.31', whose chord bears, S.83°20'38"W. a distance of 83.86 feet along the centerline of said road to the point of beginning.

The above described parcel contains 0.26 acres, more or less, and is subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars with plastic I.D. caps. North is based upon an assumed meridian.

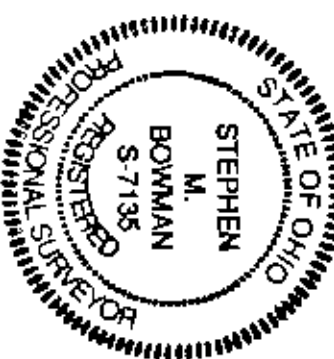
SURVEY PLAT FOR DALE CLAYTON

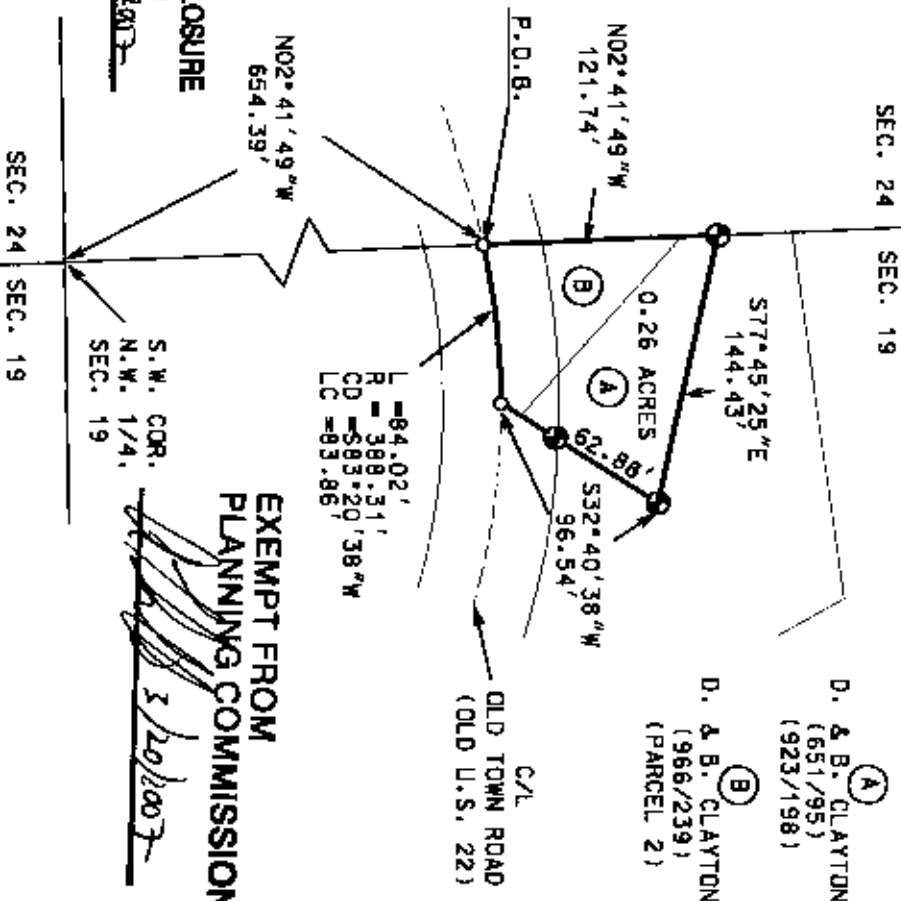
