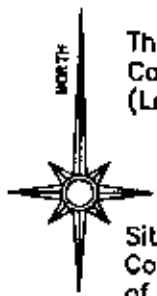

The bearings on this plat are based on State Plane Coordinate Grid derived from a Solar Observation (Local Hour Angle Method).

Situated in the State of Ohio, County of Muskingum, Village of East Fultonham:

Being all of Lot #19, and the remaining portion of Lot #18 of I.N. McCoy's Addition to East Fultonham as delineated in Plat Book 2, Page 126 of said county's plat records, being all of prior deed references Volume 1076, Page 467 (Covering Lot #19), and Volume 1043, Page 552 (Covering said portion of Lot #18), also being all of the Muskingum County Auditor's Parcel Numbers 47-47-60-02-25-000 (Covering said portion of Lot #18), 47-47-60-02-26-000 (Covering Lot #19).

SURVEYOR'S NOTES:

- Note #1 - Lot frontage for Lots 10 through 19 were prorated between an axle and railroad rail (found) at the block corners. No proration of lot length is possible due to no plotted alley width.
- Note #2 - Numerous occupation lines and subsequent surveys within this portion of the subdivision were located and are concur within reason with the survey lines shown.
- Note #3 - Railroad right of way shown is based on existing rail location and plat information.
- Note #4 - Concrete block addition. Addition clears North property line at the NW corner by 0.5 feet and the NE corner clears by 1.5 feet. The SE corner of addition clears alley line by 4.2 feet. These are measured from the outside block corner.

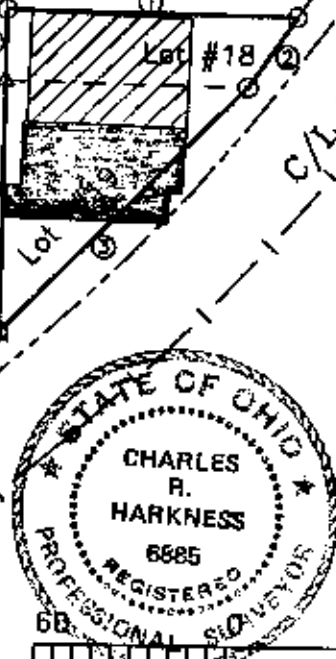
