DEED DESCRIPTION

Situated in the State of Ohio, County of Muskingum, Township of Newton, T-17, R-15, being a part of David Lee & Paul T. Eppley Vol. 937 Pg. 185, being part of the Southeast Quarter of Section 26, and more particularly described as follows:

Beginning at an iron pin found at the Northwest Corner of the Southeast Quarter of Section 26; thence along the Mid Section Line North 90 Degrees 00 Minutes 00 Seconds East 354.74 feet to an iron pin found; thence South 06 Degrees 48 Minutes 23 Seconds West 69.52 feet to an iron pin found; thence North 90 Degrees 00 Minutes 00 Seconds East 308.79 feet to a point in the centerline of Twp. Rd. 270, passing an iron pin found at 278.79 feet; thence along said centerline South 17 Degrees 39 Minutes 56 Seconds West 177.99 feet to a point; thence leaving said road North 90 Degrees 00 Minutes 00 Seconds West 601.57 feet to an iron pin set, passing an iron pin set at 40.00 feet; thence along the Mid Section Line North 00 Degrees 04 Minutes 10 Seconds East 238.63 feet to the place of beginning, containing 3.00 acres, more or less, subject to all legal highways and easements.


