Beginning at an iron pin at the Northeast Corner of the West Half of the Southeast Quarter of Section 32; Thence South $00^{\circ}42'51''$ West along the West Half of said Southeast Quarter 140.05 feet to an iron pin set on the North side of Fulton Rose Road; Thence along the North side of Fulton Rose Road the following five courses and distances: North $59^{\circ}52'05''$ West 40.95 feet to a point, North $62^{\circ}59'09''$ West 48.43 feet to a point, North $70^{\circ}14'42''$ West 74.75 feet to a point, North $77^{\circ}27'31''$ West 71.86 feet to a point, and North $76^{\circ}38'05''$ West 145.43 feet to an iron pin set; Thence leaving said road North $0^{\circ}43'29''$ East along Ohio Power Co. Vol. , Page , 23.00 feet to an iron pin set; Thence along the North line of said section and Ohio Power Co. North $90^{\circ}00'00''$ East 362.00 feet to the place of beginning containing 0.59 acres more or less:


Iron pins set are No. 5 reinf. bars 30 inches long with plastic ID caps.
