

**Virgil Slack**

Situated in the State of Ohio, County of Muskingum, Township of Newton, Township 15, Range 14, Section 33, bounded and described as follows:

Being part of Virgil Slack Vol. 500, page 122, Parcel No. 47-86-33-01-000.

Commencing at an iron pin found at the Northeast corner of Section 33; Thence North  $85^{\circ}01'02''$  West 203.23 feet to a point in the center line of State Route 93 (Station 344 + 95.03); Thence along center of Route 93 South  $19^{\circ}24'00''$  West 1095.30 feet to a point; Thence South  $70^{\circ}36'00''$  East 107.00 feet to an iron pin set on right-of-way (Station 107/334 + 00) the place of beginning; Thence along Rosehill Road (Co. RD. 696) access right-of-way the next six courses and distances South  $50^{\circ}56'46''$  East 74.33 feet to a point, South  $61^{\circ}08'16''$  East 103.41 feet to a point, South  $36^{\circ}40'57''$  East 209.68 feet to a point, South  $3^{\circ}19'35''$  West 122.80 feet to a point, South  $3^{\circ}55'04''$  East 126.32 feet to an iron pin set; and South  $82^{\circ}41'41''$  East 28.64 feet to a point in center of Rosehill Road; Thence along center of Rosehill Road South  $6^{\circ}47'21''$  West 412.47 feet to a point; Thence leaving Rosehill Road and along Lester Hurst Deed Vol. 534, page 281, North  $84^{\circ}13'25''$  West 29.60 feet to an iron pin set on State Route 93 right-of-way passing an iron pin set at 30.00 feet; Thence along said right-of-way the next two courses and distances North  $16^{\circ}19'25''$  East 617.90 feet to a point and North  $19^{\circ}21'39''$  East 297.26 feet to the place of beginning containing 8.01 Acres more or less.

Bearings are based on State Route 93 right-of-way.

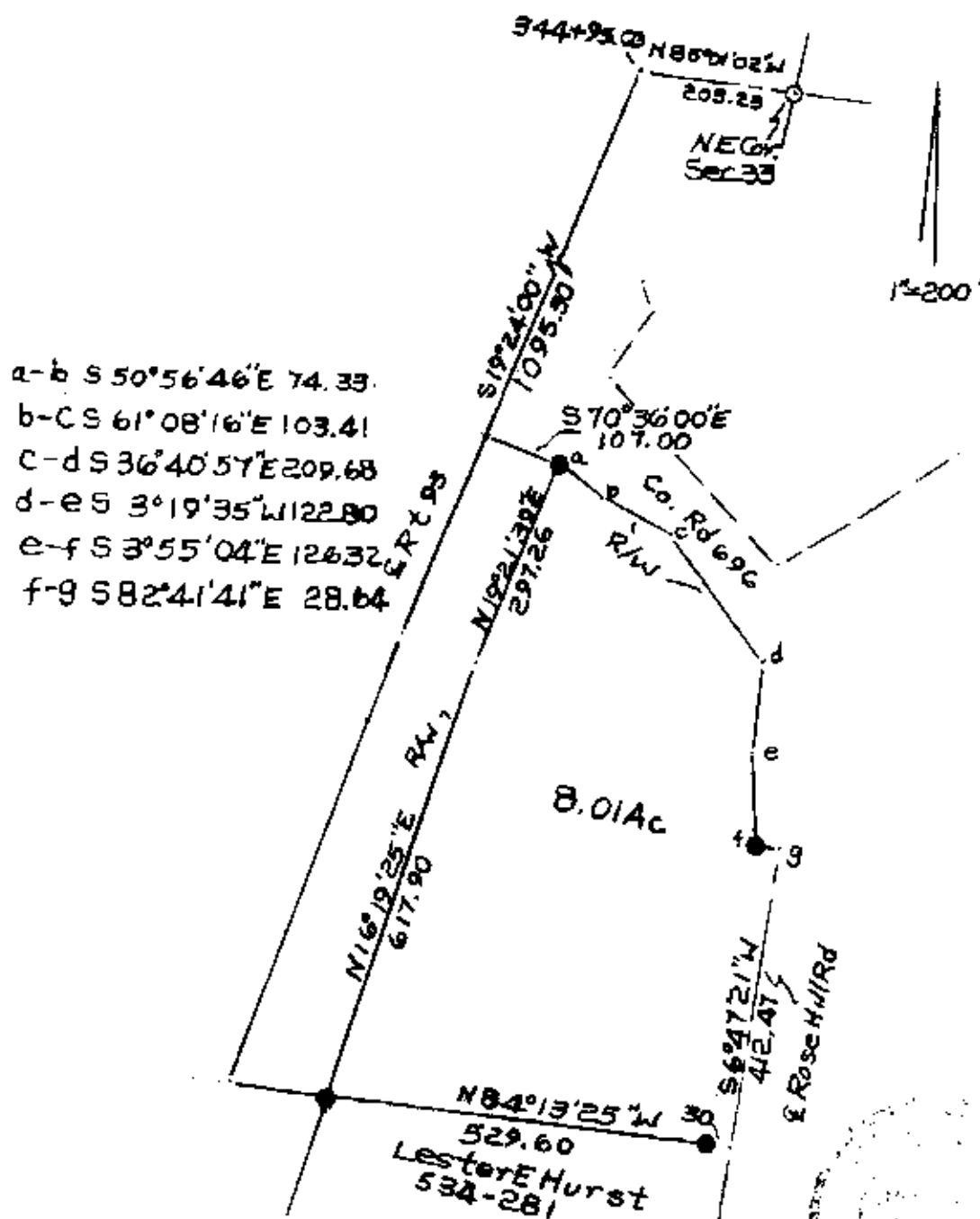
Iron pins set are No. 5 reinf. bars 30 inches long with plastic ID caps.
