Being the East half of a 40.00 foot wide street between Lots 132 and 133 of said addition; Commencing at an iron pin found at the Northeast corner of Lot 135 of said addition; Thence North  $85^{\circ}50'00''$  West along Fourth Street (50 feet wide) 120.00 feet to a point, *Place of Beginning*; Thence South  $04^{\circ}10'00''$  West along Lot 133 132.00 feet to a point; Thence North  $85^{\circ}50'00''$  West 20.00 feet to an iron pin reset at the center of a vacated 40.00 foot wide street; Thence North  $04^{\circ}10'00''$  East along the center of vacated street 132.00 feet to an iron pin found on the South line of Fourth Street; Thence South  $85^{\circ}50'00''$  East along said street 20.00 feet to the place of beginning containing 0.061 Acres more or less.

Being Lot 132 and the West half of adjoining vacated 40-foot street; Commencing at an iron pin found at the Northeast corner of Lot 135 of the First Addition to Beam City Plat Book 4, page 35; Thence North  $85^{\circ}50'00''$  West 140.00 feet to an iron pin found at the center of vacated street, the place of beginning; Thence South  $04^{\circ}10'00''$  West along the center of vacated street (Beam Road) 132.00 feet to an iron pin reset; Thence North  $85^{\circ}50'00''$  West 60.00 feet to an iron pin set passing the southeast corner of Lot 132 at 20.00 feet; Thence North  $04^{\circ}10'00''$  East along Lot 131 132.00 feet to an iron pin set on the South line of Fourth Street (50 feet wide); Thence South  $85^{\circ}50'00''$  East along Fourth Street 60.00 feet to the place of beginning passing the Northeast corner of Lot 132 at 40.00 feet containing 0.182 Acres more or less. *all Of Parcel 05 + Pt. 06*

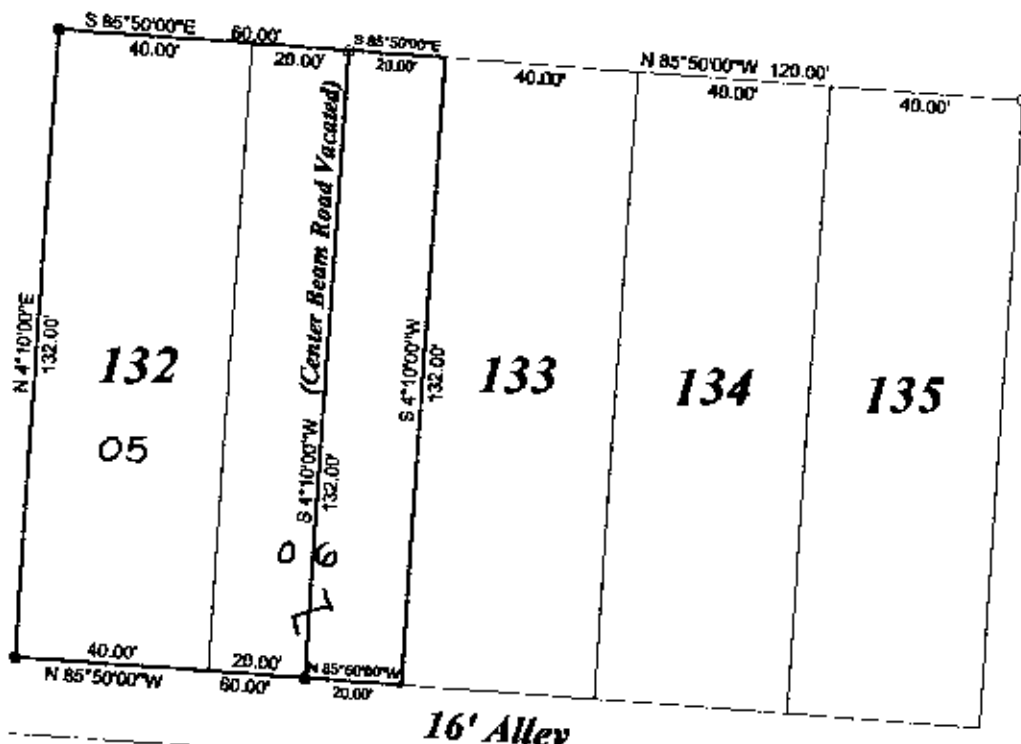

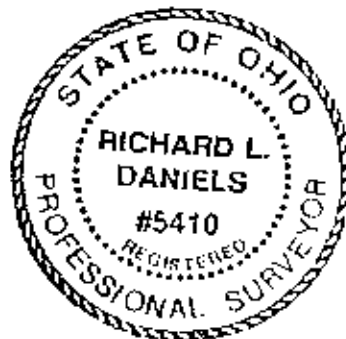
