iron pin set; thence South  $88^{\circ} 34' 54''$  East 522.34 feet to a point

26 bearing South  $1^{\circ} 34' 16''$  West.

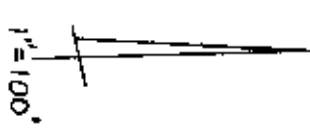
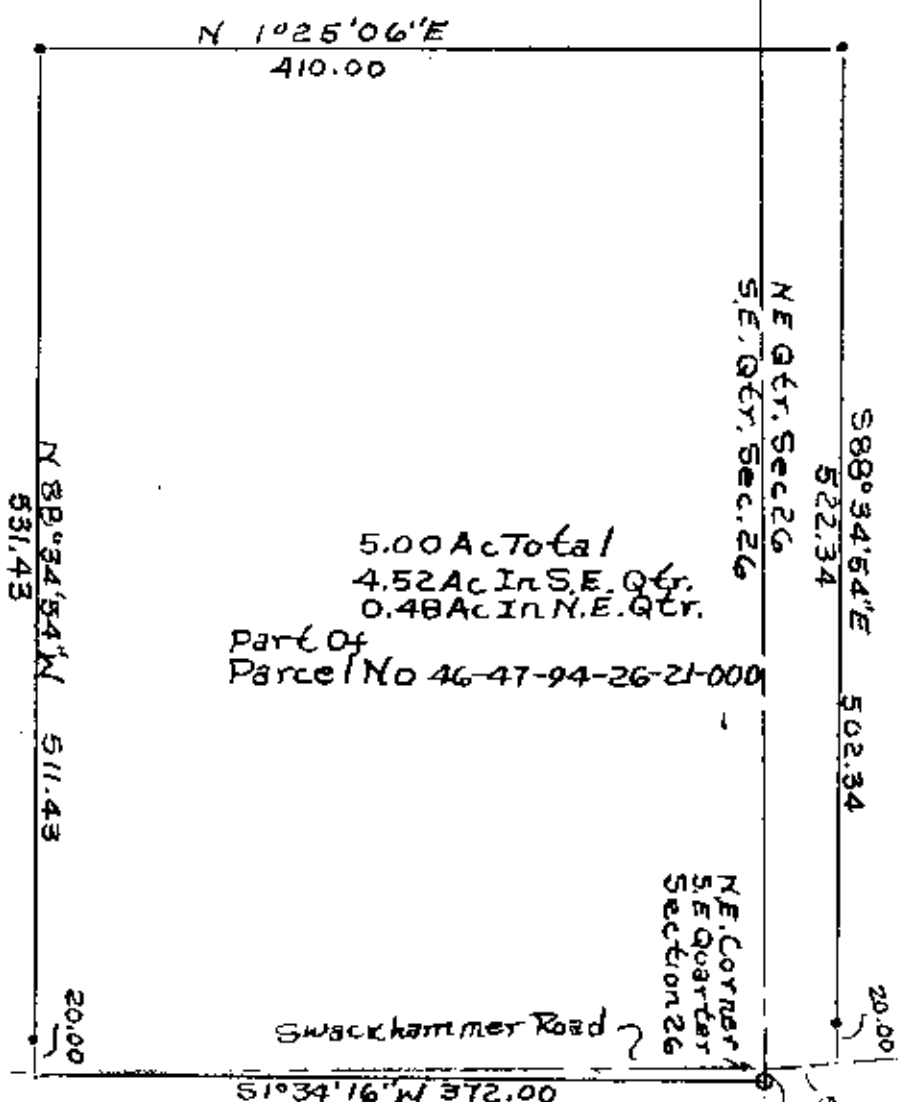
