Subject to the easements of Norfield Road.

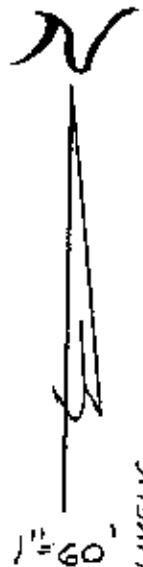


