Situated in the State of Ohio, County of Muskingum, Township of Perry.

Being a part of West Half of Section 7, Township 1, Range 6 bounded and described as follows:

Beginning at a post found at the Southwest Corner of Section 7; thence along the west line of Section 7 north 0 degrees 34 minutes 27 seconds west 2509.29 feet to a point; thence north 88 degrees 48 minutes 21 seconds east 264 feet to a point; thence north 0 degrees 34 minutes 27 seconds west 165 feet to a point in the center of Bald Hill Road; thence along the center of Bald Hill Road the following six (6) courses and distances, north 88 degrees 48 minutes 21 seconds east 33.63 feet to a point; thence south 89 degrees 49 minutes 53 seconds east 392.83 feet to a point; thence on a curve to the right having a radius of 187.57 feet an arc length of 223.40 feet (the chord of which bears south 55 degrees 42 minutes 44 seconds east 210.42 feet) to a point; thence south 21 degrees 35 minutes 34 seconds east 170.82 feet to a point; thence on a curve to the right having a radius of 317.16 feet an arc length of 181.14 feet (the chord of which bears south 5 degrees 13 minutes 48 seconds east 178.70 feet) to a point; thence south 2 degrees 40 minutes 07 seconds east 117.61 feet to a point in said road; thence leaving said road south 44 degrees 53 minutes 58 seconds west 50.48 feet to an iron pin; thence south 16 degrees 49 minutes 07 seconds west 2163.16 feet to an iron pin; thence west 260.50 feet to the place of beginning, containing thirty-nine and thirty-six hundredths (39.36) acres more or less.

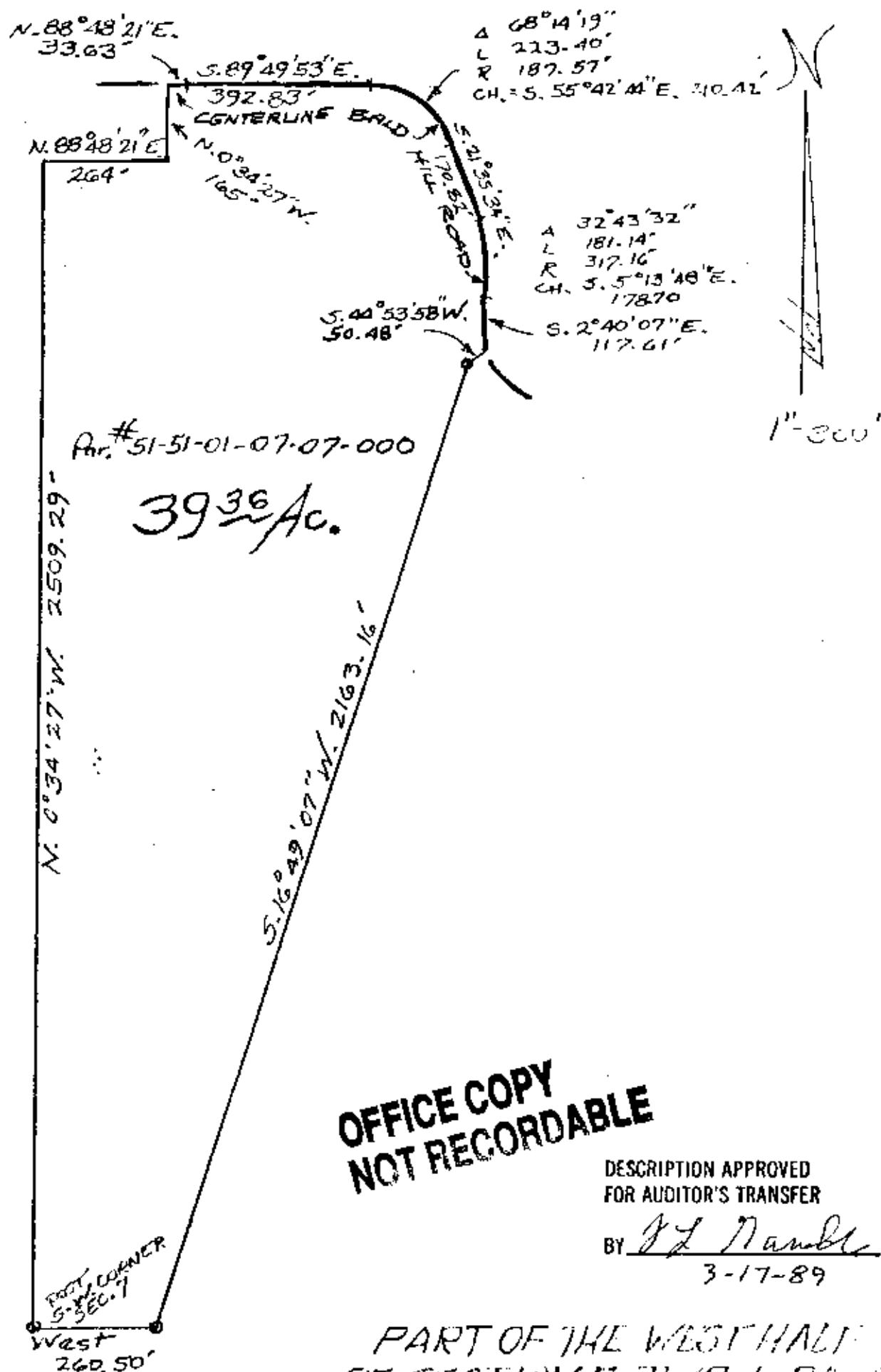
