Being a part of the Southwest Quarter of Section 6, Township 1, Range 6 bounded and described as follows:

Commencing at a stone found at the Southwest Corner of the Southwest Quarter of Section 6; thence along the west line of Section 6 north 3 degrees 44 minutes 02 seconds east 906.07 feet to an iron pin and the true place of beginning of the premises herein intended to be described; thence continuing north 3 degrees 44 minutes 02 seconds east 1310.24 feet to an iron pin; thence south 86 degrees 15 minutes 58 seconds east 241.55 feet to a stone found; thence south 3 degrees 02 minutes 27 seconds west 479.11 feet to an iron pin; thence south 86 degrees 10 minutes 30 seconds east 354.49 feet to a stone found at the northwest corner of Lot 6 of a Partition Plat Recorded in Plat Book 2, Page 157; thence south 3 degrees 33 minutes 09 seconds west 835.40 feet to an iron pin (passing through a stone found at 574.48 feet marking the southwest corner of said Lot 6); thence north 85 degrees 48 minutes 43 seconds west 604.50 feet to the true place of beginning, containing fourteen and twenty-three hundredths (14.23) acres more or less.
