COMMENCING AT AN EXISTING IRON PIN (5/8 INCH REBAR) AT THE NORTHWEST CORNER OF LOT NUMBER 7 OF BALD HILL ADDITION AS RECORDED IN PLAT BOOK 16, PAGE 120 OF THE MUSKINGUM COUNTY PLAT RECORDS; THENCE NORTH 85 DEGREES 59 MINUTES 45 SECONDS WEST, PASSING AN EXISTING IRON PIN (3/4 INCH PIPE) AT 169.67 FEET, A TOTAL DISTANCE OF 194.67 FEET ALONG THE NORTH LINE OF THE TRACT CONVEYED IN DEED BOOK VOLUME 806, PAGE 321 OF THE SAID COUNTY RECORDS TO AN IRON PIN SET, SAID IRON PIN BEING THE PLACE OF BEGINNING OF THE TRACT HEREIN INTENDED TO BE CONVEYED; THENCE LEAVING SAID NORTH LINE SOUTH 04 DEGREES 00 MINUTES 15 SECONDS WEST 16.00 FEET TO AN IRON PIN SET; THENCE SOUTH 85 DEGREES 59 MINUTES 45 SECONDS EAST 25.89 FEET TO AN IRON PIN SET; THENCE SOUTH 00 DEGREES 49 MINUTES 10 SECONDS WEST 159.91 FEET TO AN IRON PIN SET; THENCE NORTH 07 DEGREES 02 MINUTES 42 SECONDS WEST 236.56 FEET TO AN EXISTING AXLE AT THE SOUTHEAST CORNER OF A 0.082 MORE OR LESS ACRE TRACT RECORDED IN DEED VOLUME 816, PAGE 49 OF THE MUSKINGUM COUNTY DEED RECORDS; THENCE ALONG THE EAST LINE OF SAID 0.082 MORE OR LESS ACRE TRACT NORTH 03 DEGREES 42 MINUTES 01 SECONDS EAST, PASSING AN EXISTING IRON PIN (3/4 INCH PIPE) AT 155.00 FEET, A TOTAL DISTANCE OF 180.00 FEET TO A POINT IN COUNTY ROAD 67 (BALD HILL ROAD) AT THE NORTHEAST CORNER OF SAID 0.082 MORE OR LESS ACRE TRACT; THENCE SOUTH 85 DEGREES 59 MINUTES 45 SECONDS EAST 202.70 FEET ALONG THE NORTH LINE OF THE TRACT CONVEYED IN DEED BOOK VOLUME 806, PAGE 321 OF THE SAID COUNTY RECORDS TO THE PLACE OF BEGINNING.

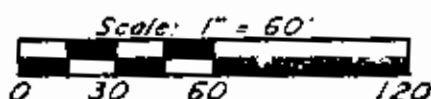
