

De Mona Sites

0.836 Acres

Being situated in Quarter-township three (3), Township one (1), Range six (6), of the United States Military Lands in Perry Township, Muskingum County, Ohio; and being that land conveyed to De Mona Sites by deed of record in Deed Volume 757 Page 190 in the Muskingum County Recorder's Office; and being more particularly described as follows:

Commencing at an iron pipe (found) at the southeast corner of Lot No. 13 of "Durbin Heights" subdivision (Plat Book 10 Page 16), thence South $04^{\circ} 44' 15''$ west along the prolongation of the east line of the said Lot No. 13 a distance of 21.38 feet to a point in the centerline of Boggs Road (County Road 108), thence North $65^{\circ} 29' 00''$ East along the centerline of the said Boggs Road a distance of 1217.97 feet to a railroad spike (set), being the true place of beginning of the herein described tract;

Thence from the true place of beginning North $06^{\circ} 34' 00''$ East a distance of 210.75 feet (passing over an iron pipe set at 34.95 feet) to a stone (found),

Thence South $82^{\circ} 24' 54''$ East along the north line of the 160 acre tract conveyed to George Little by deed of record in D.V. 103 P. 23 a distance of 352.29 feet (passing over an iron pipe set at 115.00 feet, and an iron pipe set at 280.60 feet) to a railroad spike (set) in the centerline of Boggs Road,

Thence South $67^{\circ} 57' 46''$ West along the centerline of Boggs Road a distance of 132.10 feet to a railroad spike (set),

Thence South $65^{\circ} 41' 37''$ West continuing along the centerline of Boggs Road a distance of 275.26 feet to the place of beginning; containing 0.836 acres as geometrically described herein.

Subject to all easements and rights of way of previous record or otherwise legally established.

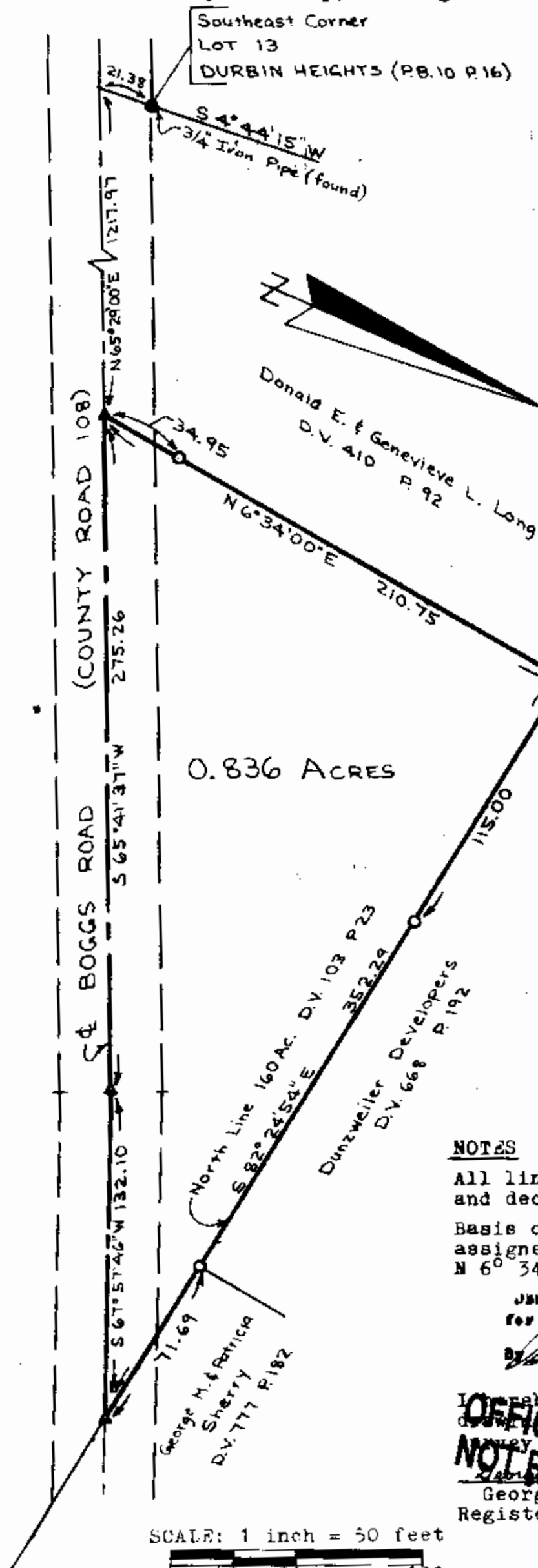

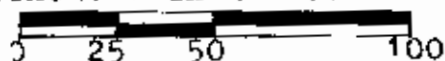
