COMMENCING AT A POINT ON THE NORTH LINE OF QUARTER TOWNSHIP 3, SAID POINT BEING THE SOUTHEAST CORNER OF THE NORTHEAST QUARTER OF FRACTIONAL SECTION 14;

THENCE WITH THE NORTH LINE OF QUARTER TOWNSHIP 3, NORTH 88 DEGREES 39 MINUTES 30 SECONDS WEST 75.40 FEET (DEED) TO A POINT;

THENCE SOUTH 02 DEGREES 10 MINUTES 40 SECONDS WEST 1378.89 FEET (DEED) TO A POINT ON THE NORTH RIGHT OF WAY LINE OF INTERSTATE 70;

THENCE SOUTH 02 DEGREES 50 MINUTES 00 SECONDS WEST 342.56 FEET (DEED) TO A POINT ON THE SOUTH RIGHT OF WAY LINE OF INTERSTATE 70;

THENCE WITH THE SOUTH RIGHT OF WAY LINE OF SAID INTERSTATE, SOUTH 86 DEGREES 03 MINUTES 20 SECONDS WEST 394.89 FEET (DEED) TO A POINT;

THENCE LEAVING THE SAID RIGHT OF WAY LINE, SOUTH 40 DEGREES 29 MINUTES 49 SECONDS WEST 568.77 FEET (CALCULATED) TO AN EXISTING IRON PIN ON THE NORTHWEST CORNER OF A TRACT CONVEYED TO R. NEWTON (DEED BOOK VOLUME 1037, PAGE 275);

THENCE WITH THE WEST LINE OF SAID NEWTON TRACT, SOUTH 19 DEGREES 50 MINUTES 40 SECONDS WEST 76.49 FEET (DEED) TO AN EXISTING IRON PIN ON THE NORTHEAST CORNER OF A TRACT CONVEYED TO R. NEWTON (DEED BOOK VOLUME 1066, PAGE 496);

THENCE WITH THE NORTH LINE OF SAID NEWTON TRACT, NORTH 72 DEGREES 17 MINUTES 20 SECONDS WEST 108.77 FEET (DEED) TO A EXISTING IRON PIN (1 INCH PIPE-BENT), SAID IRON PIN BEING THE PLACE OF BEGINNING OF THE TRACT HEREIN INTENDED TO BE DESCRIBED;

THENCE WITH THE WEST LINE OF SAID NEWTON TRACT, SOUTH 17 DEGREES 42 MINUTES 40 SECONDS WEST, PASSING EXISTING IRON PINS (5/8 INCH REBAR) AT 239.08 FEET AND 285.80 FEET, A TOTAL DISTANCE OF 325.80 FEET TO A POINT IN THE CENTERLINE OF THE OLD NATIONAL ROAD U. S. ROUTE 40 (OLD BRICK NATIONAL ROAD);

THENCE WITH THE CENTERLINE OF THE OLD NATIONAL ROAD, NORTH 69 DEGREES 35 MINUTES 40 SECONDS WEST 131.14 FEET TO A POINT;

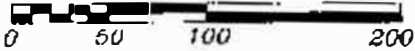
