**LEGAL DESCRIPTION**  
**TRACT 1**

Situated in the State of Ohio, County of Muskingum, Township of Perry, and being part of Quarter Township 3, Township 1, Range 6; and being part of those lands intended to be described in Deed Volume 2117, page 239; being further bounded and described as follows:

Commencing at an iron pin found at the northeast corner of Lot "C" of Durbin Heights Number 2, Plat Book 15, page 47, thence, north 68 degrees – 02 minutes – 57 seconds east, 119.63 feet, along the south line of Shimoda Lane, to a point; thence, north 21 degrees – 57 minutes – 03 seconds west, 50.32 feet to an iron pin found on the north line of Shimoda Lane, and marking the southwest corner of those lands now or formerly owned by J. & J. Nolan (2229/436); thence, north 68 degrees – 03 minutes – 17 seconds east, 139.93 feet, along the southerly line thereof, to an iron pin found, and the ***true point of beginning*** for the parcel herein intended to be described;

**Thence**, leaving the north line of said Shimoda Lane and along the easterly line of said Nolan property, **north 17 degrees – 04 minutes – 13 seconds west, 386.03 feet** to an iron pin found;

**Thence**, **north 17 degrees – 04 minutes – 25 seconds west, 23.24 feet** to an iron pin found;

**Thence**, **south 89 degrees – 12 minutes – 47 seconds east, 111.99 feet**, along the south line of those lands now or formerly owned by E.E., Jr. & P.A. Opdyke (521/12), to an iron pin found;

**Thence**, continuing along the southerly line thereof, **north 49 degrees – 27 minutes – 25 seconds east, 90.00 feet** to a point in Little Salt Creek, passing an iron pin found at 70.00 feet;

**Thence**, **south 06 degrees – 44 minutes – 22 seconds east, 407.46 feet**, along the westerly line of those lands now or formerly owned by N.J. & J.S. Harlan (1956/694), to an iron pin set on the northerly line of aforesaid Shimoda Lane, passing an iron pin found at 107.46 feet;

**Thence**, **south 68 degrees – 02 minutes – 46 seconds west, 116.50 feet** to the ***point of beginning***, and ***containing 1.338 acres more or less***.

Subject to all legal highways and easements, whether recorded or implied.

Iron pins set are 5/8 rebar with yellow identification cap (FINLEY S-7222).

Bearings described herein are based on assumed azimuth and to be used for angle purposes only.

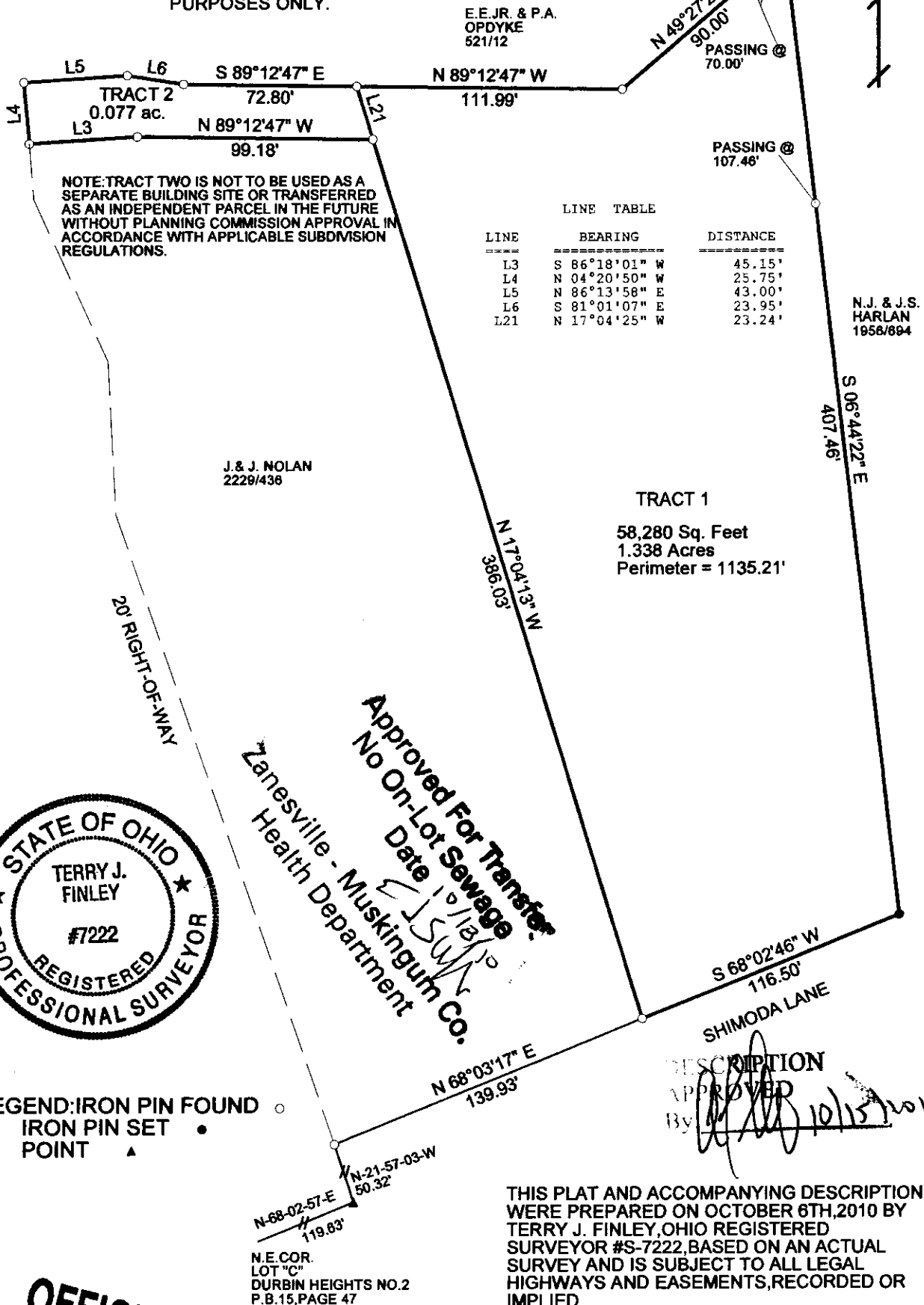
