## DESCRIPTION OF SURVEY FOR THOMAS & MARY FRANCIS

Being part of Quarter Township #3, Township #1, Range #6, of the US Military District, **being all of** the Thomas & Mary Francis property recorded in Deed Book Volume 1110, Page 62 of said county's deed records, further being known as Muskingum County **Auditor's Parcel Number 51-40-03-15-000**, and more particularly described as follows:

Commencing at an axle (found) on the East line of said Quarter Township #3, being the common corner for the Southeast Quarter of Section #13 and the Northeast of Section #18 of said Township and Range;

- TIE- THENCE North 01 degrees 38 minutes 00 seconds East 926.91 feet along the common line for said Quarter Township #3 and the Southeast Quarter of Section #13 to a survey nail (set) at the place of beginning for the property herein intended to be described, being in the roadbed of Deerfield Road (County Road #5);
- #1- THENCE South 89 degrees 53 minutes 50 seconds West 132.06 feet into said Quarter Township #3, leaving said roadbed, and along the common line of said Francis property and for a second Thomas & Mary Francis property recorded in Deed Book Volume 647, Page 131 to an iron pin (set), passing an iron pin (set) at 20.00 feet;
- #2- THENCE North 01 degrees 38 minutes 00 seconds East 131.80 feet along the common line of said Francis property and for a third Thomas & Mary Francis property recorded in Deed Book Volume 518, Page 272 to an unmarked point in the centerline of Bridgeville Drive (Township Road #363) (Old National Road), passing an iron pin (set) at 90.33 feet;
- **#3-** THENCE North 76 degrees 29 minutes 45 seconds East 105.89 feet along said Bridgeville Drive to the unmarked intersection with said Deerfield Road;
- #4- THENCE along a curve to the left having, a chord bearing South 06 degrees
  57 minutes 00 seconds East 85.02 feet, a radius of 268.83 feet, and arc length of 85.37 feet, along said Deerfield Road to an unmarked point;
- #5- THENCE South 16 degrees 02 minutes 50 seconds East 56.29 feet continuing along said Deerfield Road to an unmarked point on the common line for said Quarter Township #3 and said Southwest Quarter of Section #13;
- #6- THENCE South 01 degrees 38 minutes 00 seconds West 17.75 feet along said Quarter Township Line to the place of beginning, containing 0.38 acres, of which 0.15 acres are within the right of ways for Deerfield Road (CR #5) and Bridgeville Drive (TR #363).

The bearings within this description are based on State Plane Coordinate Grid (Ohio South 1983) derived from GPS Observations. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.6885).
