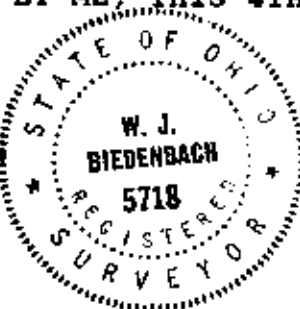

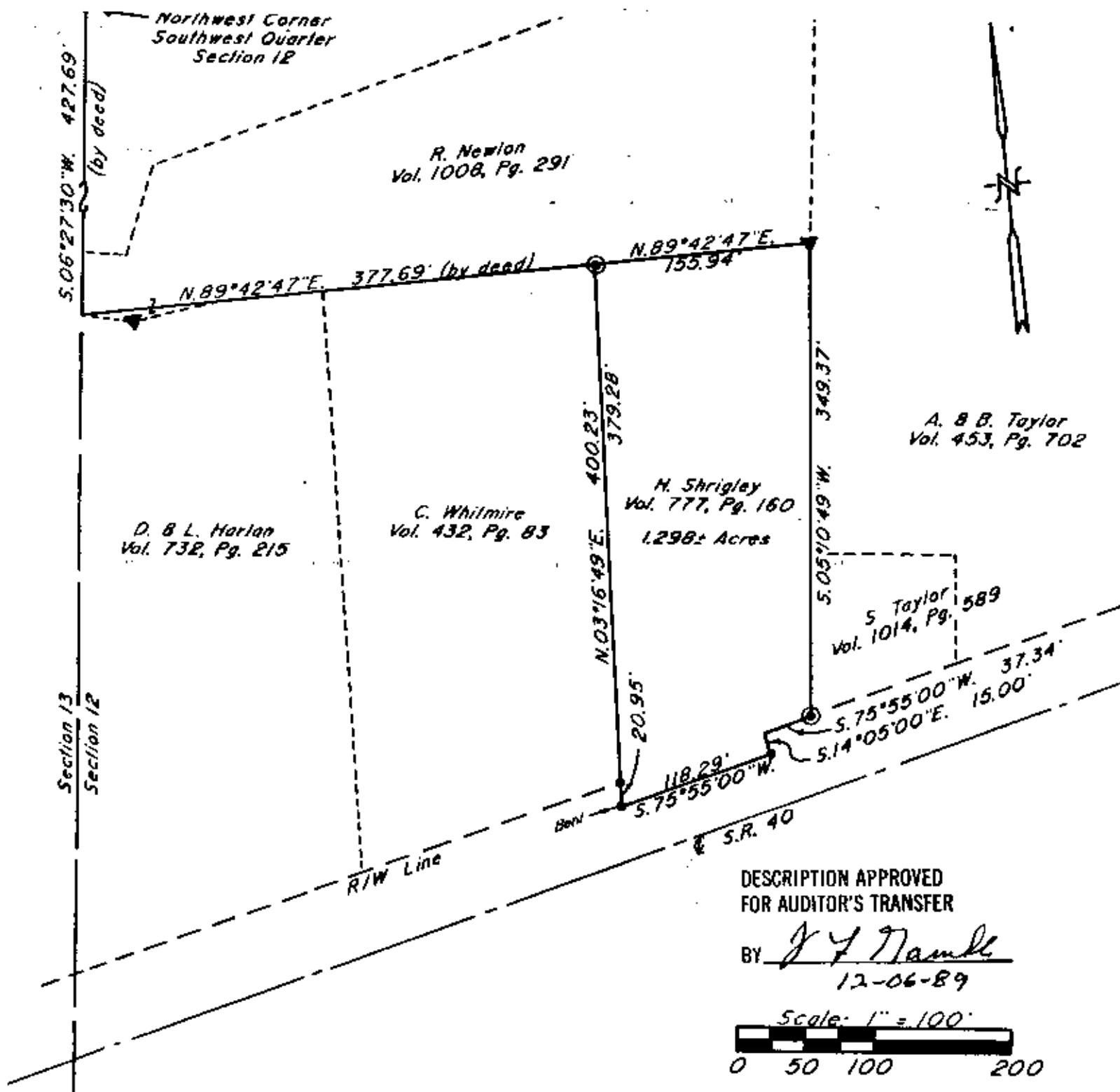

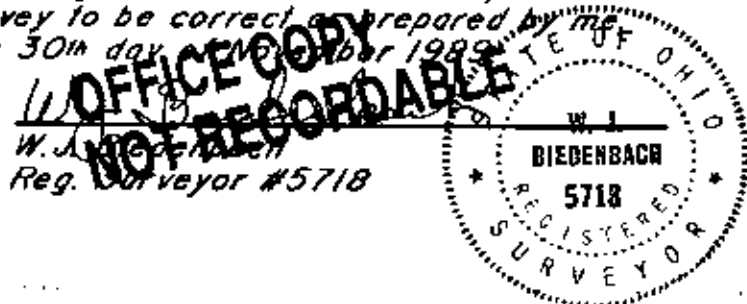




Bearings are based on the R/W Plans of S.R. 40 (N. 75° 55' 00" E. on Centerline).
