thence along the centerline of said Arch Hill Road South 20 degrees 09 minutes 20 seconds East 390.18 feet to a point at Arch Hill Road centerline station 16+09.82;

thence through lands now owned by Donald M. Castor and Jane L. Castor (DR 823-267) North 69 degrees 50 minutes 40 seconds East 154.36 feet to an iron pin set and the principal place of beginning;

thence along the centerline of said Arch Hill Road South 20 degrees 09 minutes 20 seconds East 539.67 feet to a point at Arch Hill Road centerline station 14+60.33 and the principal place of beginning;

thence North 69 degrees 50 minutes 40 seconds East 52.69 feet to a point;

thence North 51 degrees 56 minutes 06 seconds East 41.50 feet to a point;

thence North 13 degrees 59 minutes 58 seconds East 50.07 feet to a point;

thence North 14 degrees 14 minutes 56 seconds West 60.86 feet to a point;

thence North 73 degrees 19 minutes 29 seconds East 25.65 feet to a point;

thence South 16 degrees 40 minutes 31 seconds East 38.93 feet to an iron pin set;

thence South 16 degrees 40 minutes 31 seconds East 70.07 feet to a point;

thence South 10 degrees 31 minutes 38 seconds West 36.65 feet to a point;

thence South 69 degrees 34 minutes 10 seconds West 126.83 feet to a point on the said centerline of Arch Hill Road;

thence along said centerline North 20 degrees 09 minutes 20 seconds West 27.75 feet to the principal place of beginning of said ingress and egress easement.

Iron pins set are 5/8 inch diameter by 30 inch long rebar with plastic identification caps.

Bearings are based on the centerline survey of Interstate 70 between Stations 380+00.00 and 386+78.23 (386+79.25 per plat) as bearing North 67 degrees 16 minutes 51 seconds East as depicted on Muskingum County Plat Book 10, Page 59.
