Commencing at an iron pin set at the center of said Section 12; thence North 00 degrees 56 minutes 09 seconds West 58.34 feet to a point in the center of U.S. Route 40; thence along said road South 69 degrees 36 minutes 04 seconds West 539.56 feet to a point in said center at the northeast corner of a 10.000 more or less acre tract conveyed to North Terrace Church of Christ as recorded in Deed Volume 844, Page 220 of the said County Deed Records; thence along the East line of said 10.000 more or less acre tract South 20 degrees 23 minutes 54 seconds East 55.42 feet to an existing iron pin 3/4 inch pipe, said iron pin being the place of beginning of the tract herein intended to be described; thence leaving said 10.000 more or less acre tract South 33 degrees 59 minutes 25 seconds East 380.71 feet to an iron pin set; thence South 36 degrees 17 minutes 09 seconds West 107.12 feet to an iron pin set on the East line of the above mentioned 10.000 more or less acre tract, said iron pin being North 20 degrees 23 minutes 54 seconds West 64.03 feet from an iron pin set and 224.07 feet from an existing iron pin (3/4 inch pipe); thence along the East line of said 10.000 more or less acre tract North 20 degrees 23 minutes 54 seconds West 428.88 feet to the place of beginning.




