Situated in the State of Ohio, County of Muskingum, Township of Perry, bounded and described as follows:

Being the lands now owned by East Muskingum School Board (DR 574-865, DR 573-180, DR 807-315 and DR 273-308) and being a part of the southeast quarter of Section 13, Township 1 North, Range 6 West, United States Military Lands and being more particularly described as follows:

Beginning for reference at Interstate 70 centerline station 365+00 as designated and delineated on Muskingum County Plat Book 10, Page 59;

thence along said centerline North 75 degrees 31 minutes 13 seconds East 42.41 feet to a point;

thence leaving said centerline South 14 degrees 05 minutes 00 seconds East 150.00 feet to an iron pin set 150 feet right of centerline station 365+41.1 and the principal place of beginning;

thence along the south right of way of said Interstate 70 North 75 degrees 31 minutes 13 seconds East 208.63 feet to an iron pin set 150 feet right of centerline station 367+50;

thence continuing along said south right of way South 88 degrees 12 minutes 31 seconds East 143.43 feet to an iron pin set on the northwest corner of lands now owned by H. and V. Hulboy (DR 534-686);

thence along said Hulboys' west line South 13 degrees 58 minutes 05 seconds East 112.20 feet to an iron pin set on said Hulboys' southwest corner;

thence along said Hulboys' south line North 75 degrees 55 minutes 00 seconds East 498.85 feet to an iron pin set on the east line of Section 13;

thence along said east line of Section 13 South 06 degrees 38 minutes 55 seconds West 477.80 feet to a point on centerline of U.S. Route 40/22, passing an iron pin set at 413.65 feet;

thence along said centerline South 75 degrees 55 minutes 00 seconds West 676.07 feet to a point on the southeast corner of lands now owned by said D. and S. Spillman (DR 915-233);

thence along said Spillman's east line North 14 degrees 05 minutes 00 seconds West 596.85 feet to the principal place of beginning.

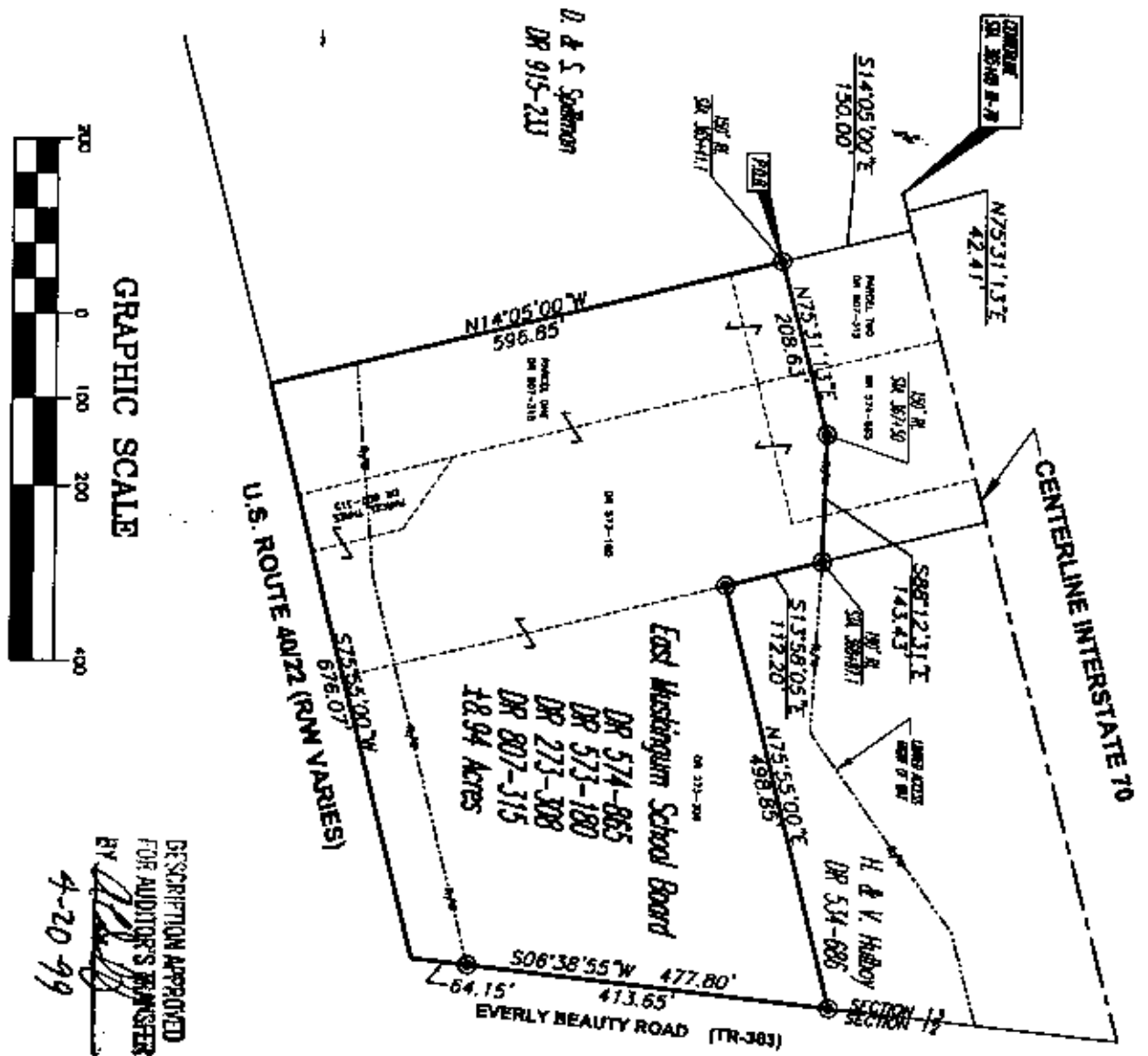


LEGEND
