

DESCRIPTION OF 1 ACRE PLUS SURVEY FOR MIKE RICE

Situated in the State of Ohio, County of Muskingum, Township of ~~_____~~ being in the 3rd Quarter Township, of Township 1, Range 6, of the U.S. Military District. Also being part of an 88.56 acre parcel of land as described in deed book 845 page 206 of said county records and is more particularly described as follows:

Commencing at a stone at the center of said Quarter Twp. 3 (Deed); thence East (1,732.5) feet to an iron pin (Deed); thence $N 0^{\circ} 46' W$ (1,163.58) feet (Deed) to an iron pin (found); thence $N 85^{\circ} 11' E$ (238.37) feet to an iron pin (found); thence continuing $N 85^{\circ} 11' 00'' E$ (50.00) feet to an iron pin set at the true place of beginning for the property herein intended to be conveyed; thence $N 4^{\circ} 31' 39'' W$ (30.00) feet to an iron pin (set); thence $N 85^{\circ} 11' 00'' E$ (132.00) feet to an iron pin (set); thence $S 8^{\circ} 23' 32'' E$ (328.31) feet to an iron pin (set); thence $S 85^{\circ} 11' 00'' W$ (154.13) feet to an iron pin (set); thence $N 4^{\circ} 31' 39'' W$ (297.67) feet to the place of beginning containing 1.076 acres.

Also being conveyed an easement for road purposes from the property described in deed book 845 page 206. Beginning at the true place of beginning for the above described property; thence $S 85^{\circ} 11' 00'' W$ (50.00) feet to an iron pin (found); thence $N 4^{\circ} 31' 39'' W$ (168.08) feet to the south right-of-way line of Twp. Rd. #366 Brown's Drive; thence along said south right-of-way line $N 85^{\circ} 08' 21'' E$ (50.00) feet; thence leaving said south right-of-way line $S 4^{\circ} 31' 39'' E$ (168.12) feet to the place of beginning passing through an iron pin (set) at (138.12) feet.

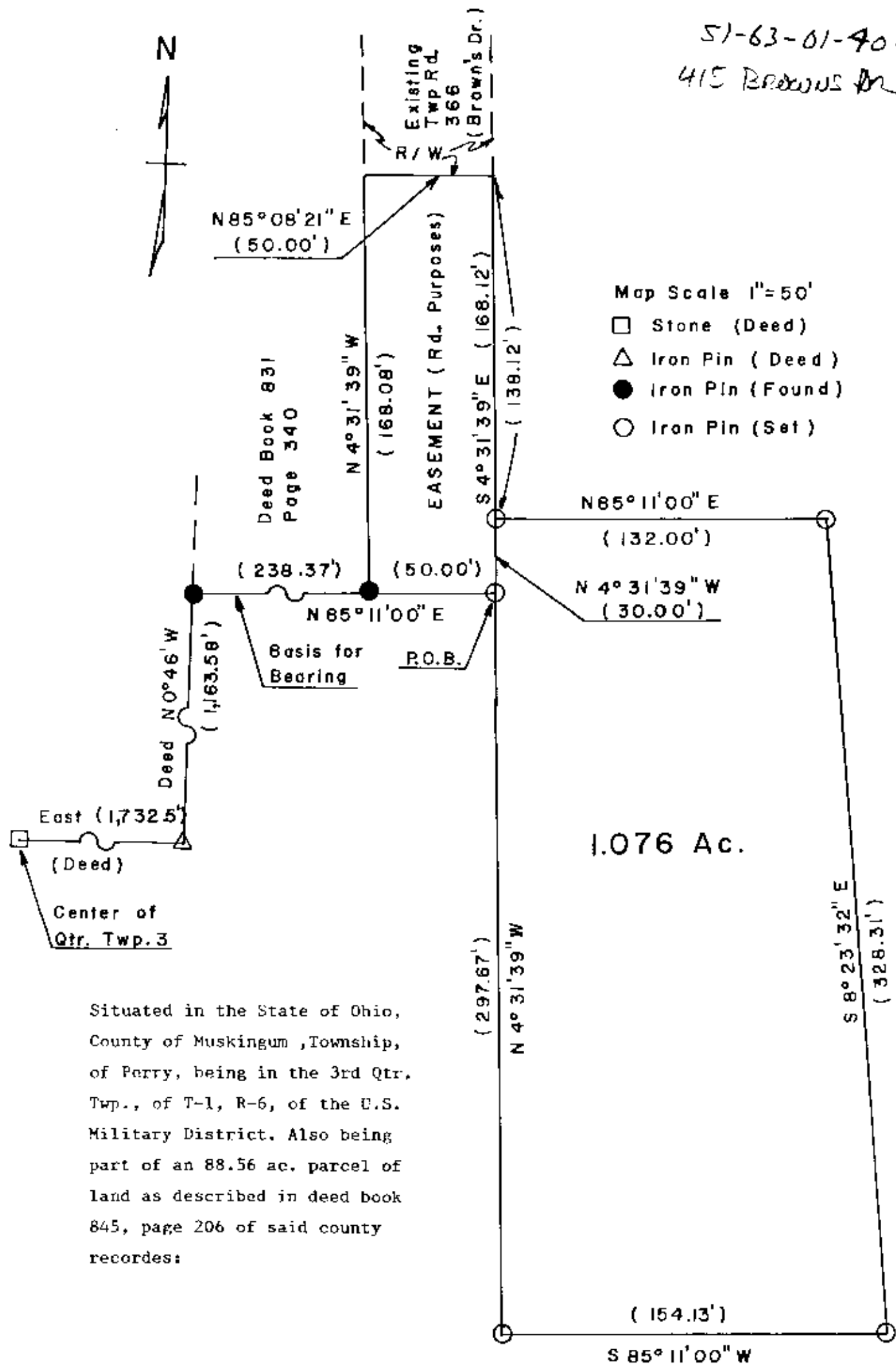
